3.1 TURANGI/TONGARIRO COMMUNITY BOARD MEETING - 14 FEBRUARY 2017

With reference to item 4.6 (second bullet), the Chair advised that NZTA had reconfigured the scaffolding at the Tongariro Bridge in such a way that it would be more difficult for children to access it.

4 REPORTS

4.1 FLOOD HAZARD PLAN CHANGE UPDATE

Senior Policy Advisor Sue Mavor was in attendance and commenced a powerpoint presentation (A1876927) on the Flood Hazard Plan (FHP). Key topics covered were:

- Resource Management Act (RMA) issues
 - The impact of flooding from rivers and Lake Taupō on peoples safety and properties.
 - Noted flood hazard area issues not currently covered in the operative district plan such as inequitable control measures i.e. insufficient in high risk flood areas and excessive in low risk flood areas.
- Background information
 - The current district plan FHP was outdated.
 - There were many statutory obligations when writing a FHP. Some plans and reference material used to inform the current FHP included the Lake Taupō Erosion and Flood Strategy 2009; Waikato Regional Policy Statement and Taupō District Plan.

Technical information

- Opus commissioned in 2014 to do flood hazard modelling/mapping on 1% AEP, including tectonics and climate change over a 100 year time span.
- Website mapping tool included colour coded flood hazard risk areas: red = high, orange = medium, yellow = low.

Quality assurance

- NIWA peer reviewed Opus work.
- IPCC update of climate change information.

Engagement

- First round of consultation undertaken in November/December 2015.
- Second round of consultation draft objectives, policies and rules seeking feedback undertaken March/April 2016.
- Open days held, survey and consultation with stakeholders undertaken.

Issues raised

 Discussed what feedback and concerns were eg WRC management and funding of flood hazard schemes, wave overtopping.

Decision making

Provided from councillor working group, regular council workshops and TTCB.

Operative District Plan provisions

- Included controlled activity and flood hazard areas at Tokaanu Stream, Tongariro and Tauranga Taupo Rivers.
- Did not identify or include all known FH areas; climate change and tectonic subsidence; risk based approach as required in the RPS and, sufficcient controls over development in high rish flood areas.
- Included some properties no longer affected by flooding and imposed unnecessary control in low risk flood areas.
- Compliance with statutory requirements
 - Complied with the RPS as it managed the effects of natural hazards on people, property and the evironments.
- Evaluation of options
 - Only one option met the requirements of the RPS and consequently the RMA.

Proposed provisions

- Care facillities for vulnerable people; emergency services and access; minisation of costs for properties in low and medium risk flood areas.

Where to from here?

- Notify Tokaanu property owners (and others) that have changed flood status; finalise Section 32

report; public notification of the Plan change and commence formal process under RMA.

At the conclusion of the powerpoint, the Policy Manager gave a brief explanation of 'wave topping', what it was and the associated risk in relation to flood hazards.

4.2 DRAFT FREEDOM CAMPING BYLAW UPDATE

Senior Policy Advisor Jane Budge was in attendance to provide an update on the progress of the Draft Freedom Camping Bylaw review, and for the Board to consider a submission for recommendation to Council.

The Senior Policy Advisor took the report as read and invited member questions. Key points noted were:

- It was desired that non approved vehicles (i.e vehicles that were not self contained) would utilise local camping grounds.
- Enforcement would be undertaken collaboratively by council staff, Senjo Security and DOC. Infringement fines were up to \$200.
- More specific detail that clarified what type of vehicles were permitted to camp in the proposed designated areas (eg. self-contained only) was suggested for inclusion in the bylaw.
- NZMCA were not happy about the perceived negative public misconception that their members –
 whose vehicles met stringent approval standards were part of the problem. NZMCA were currently
 reviewing and strengthening their standard on toilets.
- Economic benefits was the primary motivator for those towns that supported freedom camping.
- Enforcement options could not be implemented unless a bylaw was in place.
- The proposed bylaw sought to differentiate between the types of campers and enforce accordingly.
- The current Act was permissive and required only that areas where freedom camping was prohibited or restricted be highlighted.
- Historical and recent evidence implied that there was a high probability that areas eg DOC fishing trails, would be negatively impacted if there was no approved/designated camping area. It was noted that the closure of Tokaanu Marina by Genesis prompted a significant increase of campers in the Omori area.
- The Ministry of Business, Innovation and Employment had compiled spend figures of campers.
 Taupō spend was estimated at \$400 per day while the rest of the nation was approximately \$150 per day.
- Consultation on the Draft closed on 4 April.
- A member felt that the Board needed to lead discussions on freedom camping with the community. It
 was important to get community feedback and also stamp out any misinformation about what was
 actually being proposed.

A report from the Policy Manager on the King Country Electric Power Trust submission had been circulated and a copy of the Boards submission (A1890644) on the Review circulated separately.

The Chair requested that the following wording be included: 'If for whatever reason the status of the Trust cannot be modified our recommendation is that the Trust maintains the status quo'.

Another member encouraged members to advocate to the community to complete a submission. Sandra Greenslade had a submission template that people could use/modify should they wish to.

4.4 OMORI ROAD, TE PUKE ROAD AND PIHANGA ROAD INTERSECTION

A report from the Asset Manager Transportation regarding improvements at the Omori, Te Puke and Pihanga Road's intersection had been circulated.

The Asset Manager Transportation and Infrastructure Manager co-presented the item. It was explained that due to the high costs associated with the proposed work and, mixed feedback received from the Omori/ Kuratau community, it was timely to seek the Boards feedback.

At this point, the Chair invited Omori residents Messrs Tony Haddock and Mike Bowie (also Chair of the Omori Kuratau Ratepayers Association) to address the Board. Mr Haddock tabled copies of correspondence to/from Council pertinent to the upgrade of the intersection from March 2013 to 8 March 2017 (A1896136).

A resident of Omori for 29 years and member of the ratepayers association for 22 years, Mr Haddock had been concerned about the Omori/Te Puke/Pihanga Road intersection for many years. In the 1950s, Te Puke Road serviced two farms, and Omori Road approximately 25 houses. Currently, there was an estimated 350 properties/vehicles using the discussed roads on a daily basis, and significantly more vehicles during peak holiday times - especially the Christmas/New Year period. Additionally, access to the only café in Omori/Kuratau and the Omori Refuse Station was via Te Puke Road. Mr Haddock was of the opinion that current figures combined with increased road users/usage necessitated that a roundabout be installed at the intersection (without delay); it was the safest option to accommodate current day use.

Mr Bowie concurred with Mr Haddock's comments and believed that the Council plans completed in 2016 were the perfect solution. A roundabout would enable clear unobstructed views and also reduce speeds as approaching traffic would have to slow down.

The Chair thanked Messrs Haddock and Bowie for their presentation and the Board resolved to support the commencement of the intersection upgrade.

A report from the District Parks Operations Manager had been circulated along with January statistics for the Turangi Public Library, Turtle Pools and, service requests received for January 2017.

In relation to Omori/Kuratau erosion issues, the District Parks Operations Manager advised that a meeting was to be arranged with Tuwharetoa Maori Trust Board so that the consents process could then be commenced.

4.6 ADOPTION OF THE TURANGI/TONGARIRO 2016-19 COMMUNITY PLAN

The Strategic Relationships Advisor presented the item and referred to the annual format of the Community Plan (CP) noting that it could be re-formatted to cover a three year term if the Board wanted. Also, more indepth discussion on those objectives that required financial support would occurr at a later date.

Additional key points noted were:

- A member suggested using an acronym (ACT) and reducing the number of objectives to make it easier to remember primary focus areas.
- The Democracy & Community Engagement Manager suggested reviewing numbers 18 & 19 under the strand/objective 'Vibrant Parks & Public Spaces' with the Turangi Reserves Management Plan Committee as the Committee had raised some questions in relation to the content. The Chief Executive subsequently noted that there was no contraventions with the current wording.
- Over summarising content sometimes resulted in a loss of key information and meaning.
- Confirmed to remain with the status quo in relation to providing feedback on the CP i.e. by reply email, phone call or meet in person to/with the Strategic Relationships Advisor.
- CP needed to be more refined in terms of performance measures.
- LGNZ were very impressed with the detail of the CP which had set a high bench-mark for other community boards.
- CP should align with Te Kapua Whakapipi, a document that outlined the cultural, social, political and economic aspirations of Ngati Tuwharetoa. Mr New and Mr Kingi to take ownership/lead for this objective.

- Repair of pavement damage caused by heavy vehicles turning right at Ohuanga/Pihanga Roads roundabout had been programmed for April 2017.
- Past discussions with NZTA in relation to beautifying under the Tongariro Bridge area with art work had been held. However, nothing ever eventuated due to the excessive costs and onerous health and safety requirements.
- The general consensus from discussions between a member and local town centre retailers was that
 retailers felt somewhat disconnected from the Board. There was also no cohesive and consistent
 view amongst themselves. It was proposed that the Board engage with the CBD community and
 maintain regular dialogue going forward (suggested time was before Board meetings).
 - <u>Note:</u> Councillor Kingi undertook to arrange a meeting between the two parties.
- Suggested scheduling regular updates from Turangi police.
- As requested by Mr Rob Henderson, the Chair tabled correspondence (A1896138) received from him concerning the Turangi i-Site.
- The Board had met with Mr Luke Boddington earlier regarding a proposed 'Fight Night' charity event.
 Upon receipt of estimated costings from Mr Boddington, Council would investigate costs, options and
 feasibility for functional flooring to cover the pool for event purposes. Flooring would need to be reusable and easy to install and remove.
