**3.1 TAUPŌ AIRPORT AUTHORITY COMMITTEE MEETING - 13 MARCH 2017**

**4 REPORTS**

**4.1 APPROVAL TO FUND INTERIM BAGGAGE HANDLING AREA**

The Group Manager Business & Technology tabled a map, which outlined the proposed site of the interim baggage handling area [A1943736].

The following points were noted:

- The current baggage area was costing \$1200 per month to rent.
- The new proposed building could be easily removed if the terminal was to be extended in future.

- There would be an opportunity to gain revenue through advertising in the new building.
- The new building would not be lined.

There was concern that the request for \$80,000 of unbudgeted expenditure was excessive and hoped that the full amount would not be required. Members requested that the quotes, once received, be emailed to them.

#### **4.2 GENERAL MANAGER'S REPORT**

The General Manager – Taupō Airport spoke to his report and made the following comments:

- Passenger numbers were good.
- RAL were hoping to attract an extra 140,000 people and if 20% of those came through the airport that would require two extra flights per day.
- The Air NZ property team were happy with the how the airport was running.
- Landing fees for the Q300 was \$250, therefore increase in passenger numbers did not necessarily equate to increased income.
- CAA has removed the charges for audits and inspection which would mean a \$3000 saving.
- Health and safety airside, comes under the Civil Aviation Rules of which the CAA administers the act for Work Safe. Its compliance to the with aviation rules to come to the H&S meeting.
- The painted lines in the carpark area had been beneficial.
- The apron extension had started and was due to be completed in June. This included painting of the zone areas.
