## 5 POLICY AND DECISION MAKING

### 5.1 PUBLIC ART

Drawings of potential locations of the Tiki sculptures on the Col Roberts Street corner of the Ruapehu and Roberts Street intersection were tabled (A1985546).

Taupō Sculpture Trust (TST) representatives Nicki Smith, Kathy Johnston and Carol Hunter were in attendance and addressed the Council (A1985530). The following points were noted:

- “Tiki” – the artist is Albert McCarthy who is of Tūwharetoa descent. The installation incorporates three powder coated steel tiki sculptures with designs depicting the local landscape cut into them. Each tiki will be painted in a primary colour.
- 50% of this project will be funded by local businesses in the Robert Street precinct and Towncentre Taupō. The cost of the three sculptures is \$27,000 (including GST and transportation from Tauranga) and \$13,500 will come from the public art fund.
- “Hot Goss” – the artist is Auckland-based Anah Dunsheath and the sculpture will be installed on Heuheu Street. Funding is being sought from Heuheu Street businesses and the cost of the piece is \$11,500 (including GST).
- Another sculpture will be brought to Taupō in the next few weeks. “Flora Totem”, a 3m high bronze, will be on loan from Terry Stringer and installed on the Water Treatment Plant.
- It is TST’s hope that Taupō will become a destination for highly acclaimed works. The growing public art collection enlivens our town and creates experiences that increase our attractiveness as a place to live, work and visit.

Staff answered questions and the following points were noted:

- Funding would come out of the current (2016/17) financial year.
- The clip would be moved, but remain in the vicinity.
- There was a Memorandum of Understanding in place between Council and TST. Ownership of pieces of public art transfers to the Council.

## 5.6 ADOPTION OF THE ANNUAL PLAN 2017/18

The Annual Plan 2017/18 had been separately circulated prior to the meeting (A1769749).

The Senior Policy Advisor requested one further amendment to the Annual Plan, to add the following bullet point on p31 (2017/18 key projects):

- Development of the Taupō Catchment Document with Ngāti Tūwharetoa and the Waikato Regional Council, following on from the Tūwharetoa Treaty settlement process.

She asked members to provide any photographs they would like to see used in the final Annual Plan document.

Staff answered questions and the following points were noted:

- The reference to 74% in the Mayor's message related to 74% of submitters who submitted on that particular matter (the building). This would be clarified in the final document.
- The \$1m included in the investments schedule of capital expenditure (p36) for the "TDC Civic Building project" was for the investigation/feasibility work associated with the new building options.
- The average rates increase for 2017/18 was 2.4%. The Long-term Plan 2015-25 had predicted 2.5%.
- The closing debt position was down on budget. This was due to a number of reasons, including strong financial performance and deferment of some capital works (for example Waitahanui water scheme).

His Worship the Mayor acknowledged the time spent on the Annual Plan process by councillors and staff, and thanked everyone for their input.

That, pursuant to section 23 of the Local Government (Rating) Act 2002, and in accordance with the Taupō District Council's Annual Plan 2017-18, including the Funding Impact Statement the Taupō District Council hereby sets the rates and charges as set out in this resolution; (and in accordance with sections 24 and 57 states the due dates for payment of rates and authorises the addition of penalties to unpaid rates) for the period commencing on 1 July 2017 and ending on 30 June 2018:

The rates and charges are as follows:

#### 1. General Rate

A General Rate, set under section 13 of the Local Government (Rating) Act 2002 on every rating unit in the district and calculated on the capital value of each rating unit. This rate is set on a differential basis as follows:

### 2. Sewage Disposal

A targeted rate for sewage disposal, set under section 16 of the Local Government (Rating) Act 2002, assessed on every rating unit connected or available to be connected to a accessible Council scheme on the basis of one charge per pan or urinal (with the exception of the residence of a single household – which shall be assessed only one charge). For the avoidance of doubt the words ‘a single household’ do not restrict the charge to one pan/urinal in the situation where a rating unit has separately used or inhabited parts. In such a situation each separately used or inhabited part is regarded as a separate household, and a charge applied, at the sliding scale, for each separately used or inhabited part of the rating unit. (those within 30 metres of a sewage drain)

The sewer schemes are: Taupō Township, Acacia Bay, Kinloch, Waitahanui/Five Mile Bay, Whakamaru, Mangakino, Atiamuri, Turangi Township/Tokaanu, Omori/Kuratau/Pukawa, Motutere, Whareroa and Motuoapa.

### 3. Sewer Loan Servicing

**5. Metered Water Supply**

Targeted rates for metered water supply, set under section 19 of the Local Government (Rating) Act 2002, and assessed on the volume of water supplied to every rating unit with a water meter. In applying these metered water charges, the ratepayer will be provided with units of water at no charge up to the threshold at which the level of water usage multiplied by the rate per cubic metre matches the targeted rate contribution. It is only when this threshold is exceeded that water meter charges at the rates set below will be applied.

**6. District Refuse Disposal Charge**

A targeted rate for district refuse disposal, solid waste operations and waste minimization initiatives, set under section 16 of the Local Government (Rating) Act 2002 and assessed on each separately used or inhabited part (SUIP) of each rateable rating unit in the district on the basis that properties categorized as residential, rural or other shall be assessed with one charge per SUIP, and industrial/commercial, accommodation, electricity generator and utility assets and network rating units shall be assessed with twice the charge per SUIP. For the avoidance of doubt, where a rating unit is divided into separate parts for rating purposes, each separate part is treated as if it were a separate rating unit for the application of this District Refuse Disposal Charge.

## 5.8 COUNCIL'S MAY PERFORMANCE REPORT

The Chief Executive introduced the report and highlighted the following points:

- Really good feedback had been received from the public in response to the Otumuheke Stream project
- Council had retained its AA Standard & Poor's credit rating.
- The project to move staff from the Council building at 72 Lake Terrace to temporary accommodation was progressing and staff would move in stages between 28 July and 25 August.

Managers then summarised key points within their respective departments and members asked questions. The following points were noted:

- The organisation was performing well from a financial perspective.
- Pumicelands was winding up on 30 June with an operational surplus, so Council would receive a refund.
- Tenders for the Waitahanui water project closed on 21 July. Central government funding of 85% would apply.
- The Mapara Road pump station relocation project was on hold to enable Unison to design and construct a transformer to get power to the site.

A member asked whether any noise complaints had been made about Finn MacCuhals during the period. The Group Manager: Finance & Strategy would check and follow up on this query.

His Worship the Mayor acknowledged the District Events Manager for his support of the recent indoor bowls tournament, which had been a great success.

## 5.9 HEALTH AND SAFETY REPORT

The People & Capability Manager introduced the Health & Safety Business Partner. The Manager spoke to the report and answered questions. The following points were noted:

- There had been no notifiable events during the period reported upon. With approximately 330 staff members incidents of a minor nature were inevitable. Most incidents were third party incidents at the pools.
- Areas of focus for the upcoming year included: contractor management (systems and incident management); risk management; and health.
- Council currently conducts drug testing pre-employment; for reasonable cause; and post-incident or accident. Staff were currently being consulted on a draft policy which would introduce random testing.
- Training of staff who were in contact with the public as part of their role was a continual process. An example was recent training of warranted officers, which included training around how to handle aggressive situations.
