## 3 POLICY AND DECISION MAKING

### 3.1 DRAFT FREEDOM CAMPING BYLAW ADOPTION FOR PUBLIC CONSULTATION

The Senior Policy Advisor was in attendance and at the request of His Worship, briefly summarised that the purpose of today's meeting was for Council to make a decision on whether to adopt for consultation, a draft freedom camping bylaw to help manage the adverse effects from freedom camping. The key focus for the bylaw identified that freedom camping in most parts of the district be restricted to self-contained vehicles. This approach was intended to reduce the potential for environmental issues associated with the depositing of waste.

Council was asked to confirm or change the proposed time limit which was intended to ensure that freedom campers did not set up camp for a prolonged period in one location. Currently, the draft bylaw proposed a period of stay of 2 nights / 3 days which was in line with the New Zealand standard. However, 3 nights / 4 days had also been discussed which would be in line with the nightly limit for Hipapatua/Reid's Farm Recreation Reserve and would see clarity across the district.

Following discussion regarding the options available to manage the adverse effects of freedom camping, officers reiterated that Council needed to be confident that there was sufficient evidence to restrict or prohibit freedom camping. It was further noted that community perceptions on their own was not adequate evidence to justify restrictions or prohibitions. Subsequently, Council requested two changes to the draft bylaw:

- to prohibit all freedom camping on Ferry Road; and,
- that the period of stay is increased to 3 nights / 4 days

That Council

1. Agrees, in accordance with section 11(2)(a) of the Freedom Camping Act 2011, that a Freedom Camping Bylaw is necessary to protect areas of the district and the health and safety of people visiting the district.
2. Agrees, in accordance with section 11(2)(b) of the Freedom Camping Act 2011, that the Freedom Camping Bylaw is the most appropriate and proportionate way to address the issues associated with freedom camping.
3. Agrees, in accordance with section 11(2)(c) of the Freedom Camping Act 2011, that the Freedom Camping Bylaw is not inconsistent with the New Zealand Bill of Rights Act 1990.
4. Adopts, in accordance with section 83 of the Local Government Act 2002, the Statement of Proposal on freedom camping, including the draft Freedom Camping Bylaw, for consultation and invites the public to make submissions with the following amendments:
  - Prohibit all camping on Ferry Road, Taupō
  - Increase the nightly limit to 3 nights / 4 days
