3 CONFIRMATION OF MINUTES

3.1 EXTRAORDINARY FENCES, ROADING, RESERVES & DOGS COMMITTEE MEETING - 18 JULY 2017

In answer to questions the Group Manager: Operational Services advised that:

- In relation to the Taupō Rowing Club proposal, discussions between that club and the Sea Scouts were continuing, but the C75 Trust had not yet been approached.
- The self-sown silver birch trees in the reserve between Docherty Drive and Acacia Bay Road identified for removal had not yet been taken out. Staff would keep members updated.

4 REPORTS

4.1 JAN SMEATON - OBJECTION TO MENACING CLASSIFICATION OF DOG 'SAHARA'

The Consents & Regulatory Manager summarised the incident as detailed in the Compliance Officer's report. He added that there was no ability under the Dog Control Act 1996 to put temporary arrangements in place.

Mrs Jan Smeaton addressed the Committee and answered questions. The following points were noted:

- Mrs Smeaton had found the process fair.
- The menacing classification was justified at the moment, however Mrs Smeaton wanted to know if her dog could be reassessed in the future, after she had completed training to address behavioural issues.
- Training of Sahara was ongoing and the fact that she was wearing a muzzle was comforting, but she was a young dog and it was hoped that she would not need a muzzle in future.
- There was no indication that the muzzle was bothering Sahara. Mrs Smeaton was feeling more relaxed with Sahara and that was having a positive influence on the dog.
- Mrs Smeaton had taken up the opportunity to object to the classification to demonstrate her dog ownership and the support she has for Sahara in the community.

The Chairman advised that although a temporary classification was not an option available to the Committee, Mrs Smeaton could write to the Council in the future requesting a review of the menacing classification.

4.2 UPDATES TO TAUPŌ DISTRICT COUNCIL TRAFFIC CONTROLS

The Asset Manager Transportation summarised the background to each of the proposed traffic controls. The Group Manager: Operational Services corrected the distance for the proposed No Stopping At All Times marking on the Western kerblines of Atiarau Road between Te Rangitukehu Street and Katarina Street from 68 to 69 metres.

CARRIED**4.3 REQUEST FOR GARDEN ON BERM OUTSIDE NUMBER 9 CUMBERLAND STREET, TAUPŌ**

Members agreed that approving the request for the installation of a garden and netting structure on a berm, which was not permitted by the current Tree and Vegetation Policy, would create an undesirable precedent.

The Group Manager: Operational Services advised that the property owner lived in Australia and had expressed disappointment with the staff recommendation to decline his request. Attention was drawn to the points raised by the owner and outlined on page 64 of the agenda.

Members agreed that the tree could be removed, provided that the owner of the property contributed 50% of the costs of removal.

CARRIED**4.5 TREE REMOVAL REQUEST, ACACIA BAY RD, ACACIA BAY**

Mr Michael Donnelly addressed the Committee and explained the reasons for his request for the oak tree to be removed. These reasons included the fact that the tree was very large; not in keeping with other trees in the vicinity; not a nice specimen; it blocked a lot of afternoon sun; and dropped rubbish in the area. Mr Donnelly offered to contribute 50% of the costs of removal of the tree.

In answer to a question the Senior Reserves Planner advised that the tree trunk was approximately 1 to 1.5m away from Mr Donnelly's property. It was unknown if the tree was deliberately planted or self-sown but would be between 40 and 50 years old.
