3.1 TURANGI RESERVES MANAGEMENT PLAN COMMITTEE MEETING - 12 JUNE 2017

4 REPORTS

4.1 CULTURAL IMPACT ASSESSMENT REPORT

The Senior Policy Advisor introduced the item and gave a brief background summary in relation to the Cultural Impact Assessment (CIA) report. The final draft as received from Maria Nepia was attached for formal receipt by the Committee. Officers had provided feedback to Miss Nepia on some items which required further clarification or consideration.

The following points were noted during questions, answers and related discussion:

- Miss Nepia would be taking the final draft report back to the October marae meeting for final approval
- Items officers had requested further consideration/clarification on were:
 - better linkage between what influenced the recommendations for various sites (expand on current wording)
 - re-wording of some text so meaning and intent could be implicitly understood and in turn, translated into actions
- Council had commissioned CIA reports in the past eg Reid's Farm
- Any feedback from members' on the CIA was to be provided to officers so they could collate and forward on to Miss Nepia
- Ngāti Tūrangitukua had deemed sharing of detail for some sites as not suitable however, it was clarified that the RMP would be a public record that therefore needed to be clearly articulated

4.2 PRESENTATION: TURANGI OPEN SPACES

The Senior Reserves Planner summarised key points of discussion to date in relation to the Reserves Management Plan (RMP). He then took members through a PowerPoint presentation on 'Turangi Open Spaces' (A2006080) that included:

- A visual compilation of various 'welcome' signage located at Turangi entry points
- An historical overview/timeline - from the Crown confiscation of Ngāti Tūrangitukua lands for the purpose of building the Turangi township to the present time
- An overview of the Turangi RMP Committee structure and objectives
- A summary of key priorities to achieve for Turangi open spaces eg. provide higher quality facilities in selected locations
- 2013 census demographics of the Turangi population eg number of people, median age, median personal income, number of households
- Possible implications to consider in relation to Turangi residents eg increased reliance on publicly supplied services and facilities, difficulties associated with traveling to out-of-town activities
- A map of parks and reserves included in the RMP
- Discussion on Turangi playgrounds
- Council buildings located around Turangi and the associated issues
- Key points of consideration for the RMP
- Cultural and management issues

The following matters were noted during questions, answers and related discussion:

- More strategic thinking about the aspirations of the RMP was encouraged. There were opportunities to look at the bigger road map to connect communities to the open spaces
- Quantity or quality? It was important to consider the principles and priorities
- A basic map of what Te Kapua Park could look like with playing/training fields was shown. Any plan to centralise sports at Te Kapua Park would also require use of Tongariro School fields as this would increase the number of playing fields. Lengthy discussion ensued about the perceived advantages and disadvantages of relocating sports activities to Te Kapua Park / Tongariro School. In conclusion, the general consensus moved towards centralisation at Te Kapua Park however to assist the Committee with putting forward this idea to their respective networks, it was requested that officers prepare two concept plans that provided:
 1. A more detailed design plan of the Te Kapua Park / Tongariro School option
 2. An outline of the proposed priorities if activities were to remain at Turangitukua Sports Park
- A review of council owned buildings in Turangi eg Red Cross etc that was completed a few years ago showed that many were in a state of decline and non-compliant with current building warrant of fitness standards
- The Group Manager: Business & Technology would apply for LTP funding to upgrade the toilets at Turangitukua Sports Park
- Members' would be provided concept plans by 18 September
