4 REPORTS

4.1 LICENCES TO OCCUPY- CBD STREETSIDE DINING

The Solicitor-Property introduced Mr Michael Opperman, the owner of Dixie Browns. She advised that the owner of Café Baku had sent his apologies as he was unable to attend the meeting, but he had stated that he was 'not too worried' if the status quo continued.

The Solicitor-Property recommended that if the Committee agreed to grant the Licences to Occupy, (c) should be amended so that inflation-adjusted fees would take effect from 1 July 2018 to align with the Fees & Charges Policy. She added that the adjustment in fees was minor.

In answer to a question the Solicitor-Property advised that neither staff nor the owner of Dixie Browns had experienced any issues with the consumption of alcohol in the outside dining area. Mr Opperman added that although the licence hours started at 7am, Dixie Browns did not serve alcohol before 10am. Only beer and wine was sold.

 - (b) Licences to be granted to the businesses identified in Attachment One and additional CBD businesses who apply for a licence where the proposed licence area is suitable;
 - (c) Licence fees are to be the current rental fees adjusted by inflation for the period from the fourth quarter of 2014 to the third quarter of 2017, to take effect from 1 July 2018 to align with the Fees & Charges Policy.

2. To grant Dixie Browns a new licence to occupy for the blister island space currently occupied by it, and to decline the competing licence application from Café Baku.

4.2 LICENCE TO OCCUPY - MR WHIPPY AT WHAREWAKA

The owner of the Mr Whippy mobile shop, Mrs Alison Cunningham and her son were in attendance.

The Senior Reserves Planner advised that no particular site had been identified at Wharewaka Reserve for Mr Whippy to operate from. It was proposed that the operator would trial different sites on the reserve to see what worked best and then the licence to occupy documents could be updated accordingly.

In answer to questions the Senior Reserves Planner advised that:

- Mobile operators have to comply with food regulations, which are enforced by Council staff.
- Staff would monitor rubbish bins to ensure rubbish was adequately managed in the area.
- It was understood that the Mr Whippy van was self-contained and had its own power source.

4.3 LEASE RENTAL REVIEW REQUEST - BEST START EDUCARE AT WAIPAHIHU RESERVE

The Chief Executive of Best Start Educare, Mr Wayne Wright, was in attendance. Additional information from Best Start Educare was tabled (A2095317). This information included development costs and key details relating to the centre at Waipahihi Reserve.

Mr Wright addressed the Committee and answered questions. The following points were noted:

- Best Start Educare was a registered charity, self-funded and funds were used internally to improve centres.
- 130 local children had received education through the centre at Waipahihi Reserve and only 9.8% of centre income was contributed by parents.
- Since opening there had been a shortfall in income over expenditure of \$16,664. It was hoped that the centre would at least break-even in future.
- It was Best Start Educare's approach that if parents cannot pay, the children can still attend.
- Approximately 75% of the children at the Waipahihi centre were attending on a reduced fee, or free of charge.
- The organisation had the ability to 'push funds around' so that wealthier areas could subsidise lower socio-economic areas.
- There were examples throughout the country of charities running as businesses receiving relief from councils. The issue was fairness and consistency of approach.

In answer to a question the Senior Reserves Planner advised that Council had applied reduced rates to commercial operators depending on the circumstances.

Members discussed the request but decided to table the item until more information was available. In particular, they wanted to understand the charitable outcomes of the business which benefited Taupō district; and other examples of community-run businesses / charities and what they pay to use Taupō District Council land.
