

Statement of Proposal

Fees and charges 2017 – 18

We are required to consult on fees and charges for regulatory services, water supply, trade waste, solid waste and parks and reserves. All fees and charges include GST except where noted.

Where to from here

The submission period is from 12 March 2018 to 16 April 2018. When you make a submission you can choose if you want to speak to the Council at a public hearing held between 30 April to 3 May 2018. You will be given up to 10 minutes to share your view and answer any questions. We will arrange hearings in Turangi and Mangakino Council offices if needed.

If you don't wish to speak, your feedback will be presented to the Councillors in writing. The Council will consider all submissions. All submissions (including any personal information supplied) will be made available publically on the Council website.

Proposed changes

The proposed changes are outlined below and can also be seen in the following tables. Proposed additions are illustrated with underline and deletions with ~~strikethrough~~. There are minor wording changes throughout to provide clarity about what is involved in a fee, and also updates where required with the relevant bylaws.

The proposed changes are:

Animal Management

- Removal of the 'rural dog other' category so that all dogs, other than working dogs, are classified the same.
- The sale of a dog from the pound now includes the registration cost which increases this fee from \$70 to \$100. Council had previously charged the registration as a separate fee.
- Dog surrender fees have been deleted. Removing the fee will encourage dog owners to surrender their dangerous dogs rather than leaving them in the amnesty cages.
- The permit fee for processing applications where owners wish to have more than two dogs on their property has increased from \$50 to \$100. This is to cover the administration time to process the applications and now includes a site visit.

Building Services

- For building consent fees the deposit has previously been determined based on the type of consent and the values of the work. We are proposing that the same deposit be required for all applications which removes complexity and creates ease of administration when applications are lodged.
- For urgent amendments to building consents the minimum fee is now a single fee of \$450 which includes the normal amendment fee of \$150 and the \$300 urgent application fee. This change is to clarify that for those wishing to have an amendment processed urgently that there is an additional fee for this service.
- A proposed increase from \$70 to \$110 for the cancellation of inspections where the cancellations are within 12 hours of the booked inspection or where the works are not ready for inspection. The proposed increase is to align the cost with the cost of a normal residential inspection rate as the cancelled slot cannot always be filled due to location and timing of other inspections.
- A proposed new charge to provide for change of use notifications as provided for under section 114 and 115 of the Building Act 2004 (if additional building work is required to meet compliance, normal consent fees will also apply).
- There is a proposed increase for the preparation and issue of compliance schedules and amendments to the compliance schedule from \$140 to \$160 per hour. These will now be based on cost recovery rather than a set fee due to the differing levels of complexity with each application.
- We are proposing to change the audit inspections for a Building Warrant of Fitness to an hourly rate of \$160. This proposed change recognises that these inspections are based on time and that buildings that are in a poor state require significant time to complete the inspection.
- A proposed increase in the fee for a certificate for public use (s363A Building Act 2004) from \$200 to \$250 which will now include one inspection.
- A new charge has been created for urgent requests for certificates for public use (s363A Building Act 2004).

Community Services

- The AC Baths entry fees to increase: from \$8 to \$10 for an adult, \$5 to \$6 for a senior/student, child or under 5s including non-paying adult for supervision to increase from \$4 to \$5.
- There is also an increase to the AC Baths aqua fitness class fees and membership fees.
- Turangi Aquatic Centre entry fees for an adult to increase from \$4 to \$5.
- The Managakino Pool entry fees to increase from \$3.50 to \$4.50 for an adult.

Environmental health

- The transfer of auxiliary registrations is considered as a new application and as such the normal application fee will apply for new certificates.
- For Food Control Plans new applications will now be charged a fixed fee of \$500 rather than a minimum fee of \$500. This provides certainty of cost for applicants. The annual audit process and fee will no longer be included in the transfer from a certificate of registration to a Food Control Plan.
- New certificates of registration for food premises, hairdressers, camping grounds, undertakers and offensive trades previously included both the pre-opening and annual inspections. Annual inspections will now be excluded from this fee and any additional inspections that are required will be charged at the normal inspection rate of \$160 per hour.
- The removal of redundant fees for mobile shop licences which are now covered under Food Control Plans.

Miscellaneous fees in accordance with the Building Act 2004 and Gambling Act 2003

- With the repeal of the Fencing of Swimming Pools Act 1987 the management of fencing of swimming pools now falls under the Building Act 2004. The fees which were set under the previous legislation are being deleted and the cost of an inspection is reducing from \$100 to \$80.
- For Gaming and TAB Venue applications there is now a minimum fee of \$500 rather than a deposit of \$500.

Litter infringements

- Increases are proposed to the infringements set under the Litter Act 1979. These changes are to provide consistency and are set at the maximum infringement to provide a strong deterrent to littering.

Water supply

- An increase in the majority of the fees for water connections in urban and rural areas and other works such as disconnection and final meter readings. These new prices have been calculated based on the new contract that Council has in place.
- Increases at the Broadland Road Landfill and district transfer stations are due to the increased costs of the emissions trading scheme which have been passed down from central government onto local Councils. This has resulted in an increase in the per tonne rate from \$110 to \$120.
- Changes are proposed for the community pricing for the Tongariro Domain, Riverside Park and the Amphitheatre. It is proposed that the pricing structure is the same for all three areas as they are similar venues. The current charges are based on a per person basis which is challenging for event organisers to predict given most community events are free of charge to attend and as such no tickets are issued. The proposed pricing structure is intended to provide certainty for event organisers and Council.
- There is a proposed increase to the booking fee for the Rose Garden from \$25 to \$50 which recognises the administration cost in providing this service.
- New market valuations have been received for the Nukuhau boat pens. Based on the new valuation and Council's resolution to charge 85% of the market valuation there is a proposed increase of \$34 for the 11 m boat pens and a \$3 decrease for the 9.5m boat pens.

- Conditional trade waste consents for areas outside of those listed, pay the Taupō Trade Waste rates.
