3	19/05/2015	Lake Maraetai Lakefront Management Agreement	The Land Management Officer recommended that once the Lake Maraetai lakefront management agreement was finalised, an open workshop with MPRG be held to get a sense of direction for planning management decisions and Council's role in relation to the land	No changes to report. <i>Ongoing.</i>
4.6	18/04/2017	Community Issues	Around 1.5-2km of Tirohanga Road was extremely narrow and urgently required widening. Miraka trucks in particular were very long and when navigating corners, the trailer would cut in/out of the oncoming lane or road edge which presented a very dangerous situation	Funding to undertake 1.5km of widening from SH1 has been included in the draft LTP for 2018/19 financial year.
4.6	18/04/2017	Community Issues	Vehicle speed on Rangitira Drive was felt to be excessive	Speed counters were installed on Rangitira Drive in September 2017 in various locations. The location near the 100/50km speed sign return higher results than expected, although this would in part be due to traffic coming out of the 100km speed area. The location between Rotomanu Crescent and Huamai Street recording 85% just over 50km (at 52km/ph). Police were provided with a copy of the results of the traffic counters and patrols assigned. A letter was also sent to the Alpine Shuttle bus operator and a speed trailer was installed for a couple of weeks. We are proposing a speed limit reduction in the 100km speed area on Rangitira Drive and Lake Road to 80km in the upcoming bylaw review which should assist in reducing speeds coming into the 50km area.
4.9	22/08/2017	Community Issues	The GM Operational Services would arrange for an electrician to look at power issues at Tirohanga Hall	The hall mains supply was upgraded in November 2017.
4.9	22/08/2017	Community Issues	The GM Operational Services would see if there was any surplus airconditioning units at Lake Terrace building that could be re-used at Tirohanga Hall.	Upgrade of the hall heaters is scheduled for the 2018-19 financial year as there were no appropriate heaters available from the Lake Terrace building.
4.9	22/08/2017	Community Issues	The GM Operational Services would arrange for a traffic counter to be placed near the Paerata Road stock underpass	Average daily traffic count between 13 - 20 November 2017 320 Vpd with 26% heavies. This is high compared to the same time period where we were getting about 13% heavies on Forest Road.
4.9	22/08/2017	Community Issues	The GM Operational Services would follow up matters in relation to a member query about Te Awhina Hall	
4.9	22/08/2017	Community Issues	The District Parks Operations Manager undertook to follow up power charges for the park/field lights with The Lines Company	Meter work has been completed and Council now receives the power bill. We are waiting to receive the amount required for reimbursement from the Mangakino Community Agency.
