BACKGROUND

- A. The Taupo District Council ("TDC") a local authority constituted under the Local Government Act 2002 is under section 12 of that Act a body corporate.
- B. Under section 9(3) of the Property Law Act 2007 a body corporate (inter alia) executes a deed in its name by no fewer than two directors.
- C. Under the Property Law Act 2007 each of the Councillors is deemed to be a director of TDC as their position is comparable with that of a director of a company.
- D. TDC wishes to appoint attorneys to act for it from time to time in the execution of deeds.
