MEDIA AND PUBLIC: Seven members of the public

Deputy Chair Mr Robert Severne welcomed everyone to the meeting, notably His Worship the Mayor - David Trewavas, councillors and members of the public in attendance. A brief outline of meeting protocols and health and safety procedures in the event of an emergency was given, followed by a karakia to formally open the meeting.

Notes: (i) To accommodate the advised late arrival of NZTA representatives, agenda items were rescheduled and heard in the following order: 1-3, 4.2-4.5, 4.1, 4.6-4.8

(ii) His Worship the Mayor updated the Board that a constructive meeting had taken place in Taupō earlier that morning between Taupō District Council representatives, NZTA and first responder emergency services. It was agreed that in the event of an emergency, first responder vehicles would be allowed to pass through at all times. The threshold for engaging the rescue helicopter in a medical emergency had also been lowered during the road closure period, which would provide added comfort to the community.

In reply, Cr Kingi thanked His Worship for leading the discussions with NZTA, which had resulted in a positive outcome for the community.

(iii) An apology was also noted from the Head of Economic Development and Business Transformation.

4 REPORTS

4.1 UPDATE FROM NZTA: PROPOSED ROAD CLOSURES ON SH1 BETWEEN TURANGI AND TAUPŌ IN FEBRUARY 2020

New Zealand Transport Agency (NZTA) representatives Steve Griffith, acting systems manager for Waikato region and Grant Tregidga, principal network manager, were in attendance to discuss the proposed road closures on State Highway One (SH1).

The following comments were noted during questions, answers and related discussion:

- Timeline of three weeks for stop / go traffic control and full road closure would be in place from Sunday to Thursday each week (starting on Sunday, February 16) from 7.00pm and reopening at 5.00am.
- Road works would be undertaken in conjunction with construction of a retaining wall and installation of a new culvert.
- NZTA approach was to optimise a single closure over a fixed period of time to avoid adhoc works, having to return at a later date, and keep traffic disruption to a minimum.
- A member commented that there may be an issue with truckies opting to not take the alternative route around the western access and instead parking up overnight in Taupō to await the road reopening at 5.00am. This could result in a convoy of trucks once the road reopened. Mr Griffith noted that this was a valid point which he would take back to NZTA for consideration.
- In reply to a question from Mr Tregidga regarding NZTA sharing future works schedules with the Board, member's agreed that it would be beneficial to do this well ahead of any planned works as member's could better disseminate the information to the wider community in a timely manner and mitigate any anget
- The current works schedule on the NZTA website had been updated to reflect the new road closure times of 7.00pm-5.00am, Sunday to Thursday.
- There will be mobile signs at various points along SH1 to help ensure the right messages were going out to people.
- Downer contractors would be advised to avoid two sites competing with traffic control in close proximity to
- Communication from NZTA regarding delays and road closures had been unclear and disorganised.
- Mr Griffith undertook to look at some tree stumps on road reserve outside of Turangi ITM which although cleared, a member felt the area still looked unsightly.

4.2 PRESENTATION: UPDATE FROM TURANGI POLICE

Due to a call-out, Turangi police were no longer able to attend the meeting. Subsequently, as per their request this item was deferred until the next meeting.

4.3 OVERVIEW OF 2020 TREE MAINTENANCE PROGRAMME

The Parks Manager Sports and Horticulture answered questions

Additional comments noted were:

- Keeping the public fully informed of plans for Turangi trees was highly important. Future communication would be a lot better than in the past.
- Next scheduled work would be tree pruning in July 2020. This would be communicated through the appropriate channels.
- A replanting schedule to replace (approximately) 80 trees that were removed last year was being compiled. Replanting work would be done during winter.
- Were opting for a mix of deciduous and evergreen trees as these would not cause significant problems in the long-term. Property owners would also be given an opportunity to provide input.
- Deciduous trees provided a splendour of colours during autumn. Consideration would be given to managing the future leaf litter.
- There were opportunities to plant more trees on Turangi reserves and in stormwater gulley's.
- Trees recently removed from Waipapa Reserve would be replaced.
- Some planting on Motuoapa reserves had been done already.
- The focus this year was trees in the Turangi township. Flaxes would also be planted in some stormwater treatment areas.

A member noted that it was practical to have been given decision-making powers regarding Turangi trees due to personal knowledge of the area plus it further enhanced the Board's relationship with the community. Equally important was being included in the communications process. In reply, the Head of Customer Relations and Communications noted that her team would develop a communications plan / package specifically around Turangi trees and bring it back to the Board for comment ahead of the maintenance work commencing in July.

4.4 PROPOSED LICENCE TO OCCUPY FOR PROPOSED ICECREAM TRAILER OUTSIDE HAMMER HARDWARE, TURANGI

The Asset Manager Transportation spoke to the report, noting that there was two parts. The first part required approval to go against the current policy 'Guide to Mobile Shops' as the preferred location was in a non-permitted area. The second part required finding a suitable location to site the trailer as the legal team had advised that it was illegal to park on a footpath therefore Options 1 and 2 cited in the report were now discounted.

The Asset Manager Transportation then introduced Turangi Hammer Hardware manager Miss Becky Wheeler, who was in attendance to speak to their application and answer any questions. After hearing from Miss Wheeler, members resolved to support the application.

The Board's perspective was to fully support any local business growth and development to the extent practicable, especially those within the town mall.

4.5 UPDATE ON TURANGI PROJECTS

The Customer Relations Manager - Turangi went through the report. Key points noted were:

- Had spoken to Council's team leader water maintenance Paul Pettman regarding a purported wastewater breach at Tokaanu. Mr Pettman advised that although they were confident no waste had entered the stream, the process followed was as if there had been a breach ie. testing was still being undertaken
- The previous Board had approved sealing on the town gymnasium floors but a decision whether to reroof the gym was still required. A report from the facilities team about this would be brought to the next Board meeting.
- Wireless receivers report had been completed. Project estimated to be completed in March 2020.
- Kerb and channel upgrades in Te Iwiheke Place, Parekarangi Grove and Te Wharekaihua Grove should be completed in mid-May. The kerbing on the right-hand side of Te Iwiheke Place where the vacant residential lots was not included in the upgrades. Following completion, would commence upgrades along Te Rangitautahanga Road starting from Patikura Place and ending at the walkway opposite Tureiti Place. In reply to a question, the Head of Customer Relations and Communications advised that kerb upgrades were programmed through infrastructure renewals, and undertook to arrange for the GIS team to create a map showing locations for kerb upgrades so this could be shared to the public on social media and Council's website.

The following comments were noted during questions, answers and related discussion:

- There were no issues found with tree roots when doing kerbing in the Te Iwiheke Place.
- Under veranda lighting in the town mall was the shop owners' responsibility
- The Head of Customer Relations and Communications explained Council's service request (SR) system. The SR timeline was two weeks for a job to completed, with staff entering updates at each stage an action was completed. The customer services team were currently going through all outstanding SRs and closing off those which for various reasons e.g. double-ups in the system, staff overlooking closing them off properly etc had not been closed.
- A member requested that an overview of the top five key SR issues for Turangi in the previous month e.g. dogs, trees, building be provided at future meetings. In reply, the Head of Customer Relations and Communications noted that weekly reports on Turangi related matters were being compiled by the Customer Relations Manager Turangi; these could also be shared with the Board.
- The Customer Relations Manager Turangi undertook to find out whether wireless connectivity could be extended to include the Turangi mall vicinity.
- The Customer Relations Manager Turangi advised that a request had been received from a Department
 of Conservation (DoC) staff member seeking permission to do large chalk stencils in the town mall to
 promote Whio Awareness Month during March 2020.

Hundreds turn up to Tree of Light launch in Taumarunui

An estimated 450 people from Taumarunui and surrounds celebrated Matariki with KCE this week (Monday 3 July). With hot drinks, snacks and glow sticks in hand, they witnessed Taumarunui's new KCE Tree of Light shine brightly for the first time.

The tall tree, which stands proudly on Hakiaha Street next to the iconic moa, is a new initiative for the Taumarunui community from KCE. Adorned with colourful lights, it was first lit as part of Taumarunui Winter Festival Te Huapae o Matariki.

KCE community relations manager Helen Peacock said the purpose of the tree is to shine a light throughout the year on a range of special occasions and awareness events that are important to the local community.

"It will shine every evening, 365 nights per year, in a variety of colours for different causes. Currently, it is shining white until the end of the month to celebrate Matariki.

Helen said KCE is thrilled to have finally launched a Tree of Light in Taumarunui, after previously launching two other trees in Te Kuiti in 2015 and in Otorohanga this ANZAC Day.

"We were amazed at the incredible turnout from the Taumarunui community on Monday night. There are very few occasions in our town that draw that many people into the town centre at once. This truly was a unique event.

"Not only did the KCE tree look incredible, the whole town did too. Thousands of lights decorated the town centre in celebration of Matariki. We're proud to be a part of the Taumarunui Winter Festival Te Huapae o Matariki and would like to thank all involved in making the festival happen," she said.

During the launch, KCE also undertook a draw for one lucky KCE customer to win \$500 off their power account. Local resident, Arin Austin won the draw, and also had the privilege of flicking the switch to power on the tree for the first time.

KCE encourages the community to submit causes for the tree to shine throughout the year.

"We want to remind the community that the tree is about highlighting causes and events year-round. We want to listen to ideas from our community. To submit a cause or event for the tree to shine for, community members can email treeoflight@kce.co.nz," she said.

"The tree is a tangible, long-lasting way KCE can show our support for the local community and for the causes that are dear to them. We're really stoked with how Taumarunui has taken to it – the event turnout is demonstrative of that

The inaugural Tree of Light was established in Te Kuiti in December 2015 and has so far shone different colours for more than 25 causes and occasions. It has shone orange to raise awareness for victims of domestic abuse, purple to raise awareness for sufferers of epilepsy, green for World Environmental Day, pink for Breast Cancer Awareness week, and many more colours.

The Otorohanga tree was launched on ANZAC Day this year, as part of the Otorohanga Dawn Service.


