#### 4.1 TAUPŌ AIRPORT AUTHORITY FINANCIAL REPORTS - MAY 2020

The Financial Accountant noted that the monthly income from landing charges was nil; lease rebates had been approved for four sites; governments wage subsidy had been received and shown under 'Other income'; and that the loss on disposal of assets related to the transfer to council of part of Anzac Drive.

Staff had gone through budgets line by line to minimise expenses.

There were sufficient funds (\$200k) to operate the airport for twelve months with no income.

### 4.2 PROPOSED AMENDMENT TO TAUPO AIRPORT AUTHORITY COMMITTEE TERMS OF REFERENCE

The Airport Safety Committee and Airport User group both provided advice to the airport management of an operational nature, rather than at a governance level.

Consistent with 'best practice' those aspects that were of an operational nature should instead be reported via Taupō Airport Authority (TAA) management to the TAA committee, rather than by a representation on the Committee.

Therefore, members agreed to request that Council amended the Terms of Reference to include an additional business representative on the Committee, to ensure that there was a spread of skills and knowledge at a governance/strategic level. This position would replace the representatives from the Airport Safety Committee and Airport User group.

That the Taupō Airport Authority Committee recommends to Council the following amendments to the Terms of Reference to the Taupō Airport Authority.

 The removal of representatives from the Taupō Airport Safety Committee (1) and the Taupō Airport User Group (1) and include an additional business representative.

#### 4.3 UPDATE FROM THE GENERAL MANAGER

The General Manager gave an update on on his report. Key points noted were:

- Suggested changes to the Safety Committee would expand the membership of the Safety Committee; reporting would be through the respective airport user's safety managers and better align with best practice.
- The airport was operating at 70% pre Covid19. From 6 July Air New Zealand would be back to 9 flights per day.
- Having one contractor to undertake the various operations rather than mutliple contractors would create
  efficiencies and be more cost effective. The successful contractor would report to the Airport Operations
  Manager.
- Four tenders had been received and were currenlty being evalutated for the design of the new terminal.
   The completed design for the carpark would be integrated as one.
- Development of the masterplan needed to be over a 10 year horizon due to Covid19 and would be easier to implement. A key aspect was to ensure that the masterplan was incorporated into the District Plan process.
