### Introduction

In July last year we sought your feedback on three issues affecting the Kinloch community, including the appropriate level of vehicle access to the Kinloch Lakefront Reserve.

There was very clear feedback from the community that having vehicle access to the reserve was important. We have been working on how best to provide for that continued access and at the same time make a safe and pleasant recreational space. The draft design we have come up with allows for:

- Barriers to prevent driving and parking directly under the notable trees as required by the Taupo District Plan,
- Removal of the current bollards and chain and the extension of the sealed road to a turnaround point at the end of the reserve. This would allow access and parking along the remainder of the reserve.
- New planting and landscaping.

We agree with reducing the area accessible to vehicles - specially around the poplar trees. - in turn Council placing MORE PICNIC TABLES along this reserve area and PERHAPS SOME BBQ's like at the Kinloch store site. . As for maybe planting

more trees - this would have to be very carefully thought out as to what variety of tree is planted - if they grow and block views they will inevitably be poisoned !! ALSO whilst on this topic of plants - the walkway through from Keitha Place to the Lakefront requires Council to trim the hedge and plants back from the walkway. If this is NOT your responsibility please ask the relevant property owners to keep the plants BACK from the walkway and also the footpath along the entire Keitha Place road. It is difficult to stay on the footpath with children on bikes and more importantly the elderly pushing a walker or even walking with a walking stick - they require stability of course so must stay on the concrete path. . SAFETY IN THE AREA OF THE RESERVE IS ALSO TO BE CONSIDERED PARAMOUNT in your planning. Over the Christmas period and weekends in summer this area is well used by families - THINK about how you would plan your own day out at the Lake. The change in the beach alignment can be clearly identified when the current situation is compared with old photographs. The trees unfortunately have poplar rust so no longer have the beautiful autumn colours. The same type of trees were removed from the entrance to Kinloch Road to assist widening of the road. I am unaware of any public concern at the time. Long term planting more kowhai would be lovely. They attract tui and do not grow too high but still provide ample shade in the summer..
