2 REVISED DRAFT PROJECT PLAN FOR TURANGI RESERVES MANAGEMENT PLAN

A report from the Senior Policy Advisor and Senior Reserves Planner had been circulated [A1740564] along with a tracked change version of the draft project plan for the Turangi Reserves Management Plan [A1697751].

The Senior Reserves Planner took members through the document page by page and made reference to each of the tracked changes outlined in the document.

The following points/requests were noted:

- Any future changes to the Turangi i-Site reserve classification could be included in the TRMP.
- A segregation strip was normally used as a buffer to separate different land classifications.
- Additional information, including the remedies report that had been circulated with the minutes was very useful.
- Staff were still trying to determine the land status of the carpark area next to Waipapa Reserve.

In relation to the cultural impact assessment, it was agreed that the person engaged to develop that assessment possessed the relevant experience and skills, and knowledge pertinent to Ngāti Tūrangitukua. Additionally, the marae should be involved in identifying appropriate people to undertake the assessment. Council staff would develop and forward the draft terms of reference and request for proposal to Ngāti Tūrangitukua so they could then outline the scope of work for the cultural impact assessment.

A date, preferably in October, needed to be confirmed for the first hui with Ngāti Tūrangitukua to seek feedback on what they would like included in the reserves managment plan. Mr N Smallman and Ms H Mohi would advise staff of Ngāti Tūrangitukua preferred date following the marae meeting on 1 October 2016.

TRMP201609/02 RESOLVED that the Turangi Reserves Management Plan Committee:

- Adopts the project plan for the Turangi Reserves Management Plan [Attachment 1: A1697751]
- Directs the working group to advertise a public notice, in October 2016, of the Committee's intention to prepare a reserves management plan and invite interested persons and organisations to send written suggestions on the proposed plan.
