# 4.1 ASSIGNMENT OF LEASE SITE 25B

#### **PURPOSE**

For the Taupō Airport Authority to approve the assignment of lease Site 25B.

#### **DISCUSSION**

Site 25B is currently leased by Kate Wills of Venture 25. Ms Wills has operated a business selling skydiving equipment from this site for a number of years and is now having a change of career.

Ms Wills has entered into a sale and purchase agreement with Grant and Francis Ellery to purchase the building on the lease site however, approval of the lease assignment is required by the TAA Committee.

# 4.2 REQUEST TO EXTEND LEASE SITE 26 HANGAR AREA

#### **PURPOSE**

To permit a 3.4 metre extension to the front of the hangar on Site 26.

#### **DISCUSSION**

Paul Munro of Munro Investments Limited leases Site 26. He has acquired a second aircraft which he would like to house in his hangar. The hangar could fit two aircrafts however it would be a tight fit and this would create risk of damage to either aircraft. To counteract the issue of not enough space, Mr Munro is proposing to add an extension to the front of the existing hangar.

#### CONCLUSION

The extension of the building would bring it forward however, it would still be within the lease site boundary.

#### **RECOMMENDATION(S)**

That the Taupo Airport Authority Committee approves the request from Mr Munro to extend the front of the hangar on Site 26 by an additional 3.4 metres.

# 4.6 LOCAL GOVERNMENT ACT 2002 SECTION 17A REVIEW OF ECONOMIC DEVELOPMENT ACTIVITIES

#### **PURPOSE**

To brief the Taupō Airport Authority Committee [TAA] on the s17A review of economic development activities.

### DISCUSSION

Taupō District Council has received NZIER's s17A review of Council's economic development activities which includes the Taupō Airport Authority.

Specific points in relation to the TAA are as follows:

- Its activities meet the market failure test and the TAA is operating in the right space.
- The fact that the TAA is self-funding [rather than through rates] needs to be communicated better to the community.
- The district is in need of an economic development strategy which will have application to the TAA.
- Current governance arrangements of the TAA [as a Committee of Council] is not consistent with the Auditor General's guidelines for a CCTO, although no concerns have been raised during audit process. It is however recommended that this be reviewed.
- The passenger terminal is reaching operational constraints. The terminal needs to provide a
  welcoming environment that matches the expectations of travellers while delivering value for money.
  Any development of this area needs to be aligned with TDC, DGLT, and the wider economic
  development strategy.

# CONCLUSION

The report along with recommendations on next steps is being presented to a Council workshop on the 27 June 2017.

A full copy of the s17A review will be circulated separately.
