4 REPORTS

4.1 PRESENTATION: UPDATE FROM GO TONGARIRO

Go Tongariro Chair Wayne Smith was in attendance to provide a progress update on Go Tongariro activities for the past twelve months. Mr Smith thanked the Board for the opportunity to present and proceeded to read aloud his report [A1975767]. Key points of discussion were:

- The Turangi to Taupö shared use/cycle trail project was ongoing and the estimated project cost was \$18M. A feasibility report and project business plan were completed in November 2016. The report identified funding and tenure issues as the greatest challenges in particular, a large proportion of land area required for the trail traversed Maori owned land blocks. Engagement with landowners and hapu needed to be undertaken prior to funding be sought.
- Go Tongariro continued to work with and advocate for TDC, EGLT, DGLT, TCT, TTCB, Taupö Chamber of Commerce, Turangi Police and Taupö events team.
- Supported and assisted with various local events including Stella & Business Awards [for Turangi], Turangi Christmas in the Park, River Wild, Kuratau Fishing Day, Turangi Junior Triathlon, River Shiver, Lead Central Custom Car Swap & Meet and, Battle of the Lakes.
- Initiated and oversaw installation of new flags/banners; 'This is Turangi' pictorial signage; information signage; Turangi town centre picture board; and Christmas decorations in the town mall.
- Facilitated and supported new businesses, workshops eg governance and Elemental Potential communication, 'activity map' promotion for local businesses and, monthly Turangi After 5 meetings.
- RPS Consultants NZ Ltd would facilitate a workshop in June to provide a summary of findings from
 research undertaken to date on the Turangi Economic Development Strategy [TEDS]. The outcomes
 of the workshop would inform the action plan. The final TEDS draft document which would also be
 presented to the GT Board and Advisory Panel by the end of June.
- Upon reviewing TDC Annual Plan submission feedback in relation to GT's request for additional funding, it was evident that many people were not aware who GT was. The Board would look at ways to increase effective communication.
- GT acknowledged the positive relationship it had with the Board and looked forward to progressing that further to achieve positive growth for Turangi.

The following was noted during questions, answers and related discussion:

- It was possible to do smaller sections of the shared user/cycle trail eg to Stump Bay initially.
- The Parks Operations Manager Turangi was arranging the installation of picture boards GT had purchased for the town centre.

4.3 TURANGI OPERATIONS REPORT - MAY 2017

The District Parks Operations Manager presented his report.

The following was noted during questions, answers and related discussion:

- Unprecedented rainfall further accelerated erosion issues at Te Rangiita and Omori/Kuratau areas.
 Fortunately, Te Rangiita foreshore was re-forming and regrading through a natural process however, beach nourishment work had already commenced under an existing resource consent for Omori/Kuratau. Tonkin & Taylor engineers were working on a more long-term plan for that area.
- Urgent remedial repairs were currently being undertaken at Parehopu Street carpark.
- Following a complaint from a local sports code about the quality of facilities at the Turangitukua Sports Park, it was identified that there was a communication breakdown. Going forward, a procedure that aligned with Taupö for sports club requests eg line marking, etc, would be implemented.
- A member noticed there was some black marks on the bottom of the learners pool.
- Broken fencing adjacent to Hirangi Marae was being used by vehicles to enter the sports park and cause damage to the fields.
- A member commented that recent weekend rugby matches at Turangitukua Park were well attended however it was disappointing there was no decent facilities - especially changing rooms for children.
- Notification given of the Parks Operations Manager Turangi's pending resignation from her position in August 2017.
