#### 4 REPORTS

#### 4.1 OBJECTION TO MENACING CLASSIFICATION OF DOG 'IKE'

The Consents & Regulatory Manager summarised his report. In response to a question, he advised that the dog classification evalution forms had recently been introduced when lke was classified as menacing. There was some inconsistency between the two forms completed in relation to the incident.

Mr and Mrs Brasell addressed the Committee and answered questions. Their dog lke was also in attendance. The following points were noted:

- Scotty's real name is Frank
- There were issues with Council processes in relation to the classification of Ike, including a note on the gate "Hi, there's been a dog attack" and when Mrs Brasell rang the number provided she left a message and never heard back.
- They had contacted the postal worker's employer and asked if they could do anything to support her, however were told that she was fine.
- Ike had never shown agression prior to the incident or since. He is a rescue dog. Jumps up for cuddles
  and attention, perhaps this is what happened when the postal worker came along.
- As owners of the dog, Mr and Mrs Brasell should have been part of the initial investigation and observations of the dog following the incident.
- Eventually two letters arrived in one envelope on the same day one asking to fence the property and the other classifying lke as menacing. Mrs Brasell telephoned the Council asking if there was any point objecting to the classification and was told that lke was definitely menacing. They only decided to object when the realised he would have to wear a muzzle.
- Mr and Mrs Brasell have not taken lke out to exercise because they do not want to put a muzzle on him.
- The gate now stays shut and the Brasell family is doing its utmost to make sure the public is protected.
- Ike had lived with the Brasells for six years with the gate open and during that time there had been no problems, no agression. The attack was completely out of character, misconstrued.
- Ike does not have a 'run'; he just mooches around the property. He does not like kennels outside because it is too cold in winter for him.
- Mr and Mrs Brasell now introduce new visitors to lke, for example meter readers.

In answer to a question, Mrs Brasell assured the Committee that she and her husband would continue to control lke and keep him safe and secure at all times.

The Chairman reserved the Committee's decision at this point (11.05am). Members deliberated later in the meeting (11.46am) and decided to rescind the menacing dog classification of lke, having regard to the following as summarised by the Corporate Solicitor:

- The Dog Control Act 1996.
- Original evidence provided on the agenda for the meeting, including details of the injury to the postal worker; the classification and evaluations by officers; and steps taken to avoid threats in the future, including fencing.
- Evidence provided by Mr and Mrs Brasell at the hearing, including an undertaking to contain the dog
  when they are not at home; and steps they will take to control lke, as they are conscious of his
  boisterous nature.

#### 4.2 LICENCE TO OCCUPY - MOBILE FOOD OUTLET PARKING, TOKAANU

Ms Toni Konui addressed the Committee on behalf of the applicants. The following points were noted:

- The safety of the public was the prime concern in considering the location of the mobile food outlet. Either a position in the middle by the Puanga Street sign or on the grass area by the pink car on the map provided would be good.
- It was important to be mindful of the fact that this was a thermal area. The pool manager had said there was a geyser near to the pink car. The applicants were working with The Lines Company and the pool manager to work something safe out.

In answer to questions, Ms Konui advised that:

- The applicant's preferred option was option 2 road shoulder. That way they could serve customers standing on the grass area. It was possible to get the cables to that area. Option 1 would work as well.
- The trailer was a square shape with door opening on the side / front it will be turned around and positioned carefully bearing in mind the tow bar.

In answer to a question, the Asset Manager – Transportation advised that the main area of concern from a traffic safety perspective was where the vehicles come out of the exit. To mitigate this, it would be better for the mobile food outlet to park closer to the entrance way.

In answer to a final question, the Chief Executive and Ms Konui confirmed that both Te Kotahitanga o Ngāti Tuwharetoa and Ngāti Kurauia support the application.

Members decided to approve the licence to occupy, subject to confirmation of the final location being agreed by the parties.

#### FRD201805/04 RESOLUTION

The view of the lake and the boats operating on the lake mean so much to me, and I am sure to the





Further to our telephone conversation, we wish to apply for an extension to our ground lease of the Tongariro Domain, which expires on 31 August 2027.

The bowling club is in discussions with the Taupo RSA who wish to enter into an agreement to cohabit the club rooms and have offered a substantial sum to invest in joint ownership to achieve this result. Unfortunately, with only nine years to run on the current lease, they are reluctant to proceed without security of tenure.

In the case of the bowling club, we have spent almost \$100,000 upgrading our club rooms and are in the process of continuing with the expenditure of \$74,000 and if the proposal from the RSA does not proceed, we also wish to have security of tenure beyond nine years before we proceed.

We therefore request the Taupo District Council grant an extension for a further two terms of six years with a deed of variation to the ground lease of the Tongariro Domain.

Kia ora Dennis,

Further to our conversation earlier this year I wish to ask Taupo District Council to consider leasing the adjacent section to the west of Taupo Kids Community for the purpose of building a bike track.

#### Background

As part of the activities that TKC offers we have our tamariki learning to ride bikes around an area inside our fenced centre. Through this activity we have watched tamariki confidence grow as they have learnt skills ,socialise with one another and importantly have fun. With support from Cath Oldfield of Bike Taupo our students are also learning an important skillbase prior to them beginning primary school and we recognise that we are fortunate to be possibly able to build a track in an area which other preschool facilities will also have an opportunity to use.

#### Land

The land we are seeking to lease currently is not used by Council in any real way and can be defined by boundaries which are our fenceline, a bush area which backs onto the reserve and Waikato river, a row of trees painted to seperate the two parcels on land in this area and the roadside.(see attached map). There would be no direct access to this area outside of Centre hours.

#### Costings

1

Taupo Kids Community would pay for the construction of the fence around the area as well as the materials for building the track .Access to this area would be via a gate into our play area and also a gate on our boundary that allows outside groups to access this area without affecting our programmes (toilets would be available to visiting students inside our centre during opening hours.)

Advice will also be sought from Bike Taupo and other bike organisations as to the best design for our track .

#### **Further Considerations**

On the accompanying map I have also marked two areas. In the case of car park area 1 there may be room to establish a space for some staff parking for our centre if allowed.

Carpark area 2 is the area that I have discussed with you and I have been contacted by Council staff about a possible road access to this area to creat a car park which would also act as a buffer for our centre should this space become an option for freedom campers.

I am happy to come to a meeting to discuss this further and strongly believe this will be a space that not only benefits TKC but also the wider preschool community.

I also wish to thank you for the positive conversations we have had so far.
