#### **PURPOSE**

#### DISCUSSION

#### 4.4 DRAFT ROAD ENCROACHMENT POLICY

#### **PURPOSE**

This item is for the Policy Advisor to discuss the Draft Road Encroachment Policy.

#### **DISCUSSION**

A Draft Road Encroachment Policy has been developed to assist with managing the wide range of encroachments that are present in our road reserves.

The draft policy includes an approach to deal with parking of vehicles on Council berms, which is a particularly controversial issue. Currently there are limited bylaw tools available to control this activity. The draft policy also allows for people to apply to Council for approval to erect bollards on the berm outside their property. Staff would assess the application and if approved, the bollards would need to be constructed to a specific criteria and maintained by the property owner.

Staff would like the Board's input on the draft policy and feedback on the following:

- 1. Do you think that there is an issue with people parking on berms?
- 2. Do you think Council should adopt a policy allowing bollards in appropriate circumstances?

#### 4.6 SCULPTURE PROPOSAL - THE TUNNELLER

#### **PURPOSE**

This report will discuss a proposal to install a public art sculpture on the northern end frontage of the Turangi Town Centre.

### **RECOMMENDATION(S)**

That the Turangi/Tongariro Community Board recommends to Council to approve unbudgeted expenditure up to a maximum of \$5,500 (excl GST) for the installation of 'The Tunneller' statue and, the location of the preferred site as identified in Appendix 2.

#### **BACKGROUND**

The proposal has not been presented previously.

Officers have been approached by Mr Zane Cozens with a proposal to install a public sculpture on the Ohuanga Road berm adjacent to the recently rebuilt business premises of Mr Cozens.

#### DISCUSSION

The full interpretation of the piece as provided by Mr Cozens is contained within Attachment 2. However in summary, the sculpture recognises the contribution of the tunnel workers in the development of Turangi as a hydro town.

Council's role is to make an impartial decision whether to fund a piece of public art and the location of it only. This item seeks Council's approval of both funding of a public art piece and location (see Attachment 3).

Council continues to support public art in the form of joint funding arrangements on a 50:50 basis however the current year 2018/19 public art budget has been expended. As a result, Council will have to make a decision on whether to approve unbudgeted capex to fund this project.

It is the intention that the sculpture is donated to the community however funding is required for its installation. Full costings are not available at this time but it is anticipated that this will be circa \$5,500. It should also be noted that Council will enter into a formal memorandum of understanding (MOU) with the person/persons gifting the piece if the proposal is accepted.

Based on this information it is considered that there are two options:

- 1. Partially / fully fund the installation
- 2. Do not fund / delay the project

## **OPTIONS**

#### Analysis Conclusion:

Council has recently approved unbudgeted expenditure for the Dreamer of Peace statue in Taupō and as such it is wholly appropriate to consider funding this installation.

#### **CONSIDERATIONS**

#### **Financial Considerations**

The financial impact of the proposal is estimated to be \$5,500

## Long-term Plan/Annual Plan

The expenditure outlined is currently unbudgeted. It is requested that unbudgeted expenditure is approved. Unbudgeted expenditure is preferred because the current fund is exhausted.

## SIGNIFICANCE OF THE DECISION OR PROPOSAL
