# 4.1 RECEIPT OF WAIKATO CIVIL DEFENCE EMERGENCY MANAGEMENT JOINT COMMITTEE MEETING MINUTES

Cr Anna Park advised that the Waikato CDEM Joint Committee minutes had since been confirmed at a meeting held last week on August 2, 2021.

#### 4.2 CIVIL DEFENCE EMERGENCY MANAGERS' REPORT

The Emergency Managers' jointly presented their report and answered questions of clarification.

The Central Plateau Volcanic Advisory Group (CPVAG) committee core business was related to the three cone volcances that traversed the Waikato and Wanganui regions. The administration of the CPVAG was shared between Waikato and Horizons Councils, with Horizons having overseen this role for the past 3 years. Waikato CDEM would administer this for the next 2-3 year period.

The CPVAG was established in 2007 following the Mt Ruapehu lahar and included representatives from various organisations including KiwiRail, Ruapheu Alpine Lifts (RAL), Department of Conservation, police, the army, Genesis Energy, MetService and Waikato and Horizons regional councils' civil defence teams. Learnings from the Whakaari eruption were being used to inform how best to protect people and better evacuation procedures on the mountain.

Additional points noted were:

- The unimog was a highlight for Tauhara College students when the team visited in March.
- Discussed the need for Pāmu Farms to increase the amount of generators on site and feed held in stock during an onsite visit.
- Demonstrated how to use a fire extinguisher at the Waitetoko Marae preparedness visit; surprised how
  many people did not know how to operate these.
- Whanganui Bay Marae preparedness plan looked at options to keep their community safe in the event of a fire as the access road to the settlement was unsuitable for a fire engine.
- Te Kura o Hirangi students were currently doing an assignment on the Hipaua Steaming Cliffs following a lesson on this during the team's visit. Two students with the highest scored assignments would be taken onboard the next Hipaua flyover.
- Tauhara College students had been given an assigment to design a cooker that could be used in an emergency without the need for gas or power. The CD team had sponsored some prizes for this.
- Emergency manager Hadley Tattle was now licenced to drive the unimog.
- Positive feedback had been received from the updated MOU agreements sent to Rotorua, Ruapehu, and South Waikato. The draft MOUs would be brought to the Committee to review once finalised.

#### 4.3 WAIKATO CIVIL DEFENCE AND EMERGENCY MANAGEMENT GROUP UPDATE

Waikato CDEM group manager Mr Julian Snowball gave a verbal update to the Committee.

- An update had been provided to the Waikato CDEM Joint Committee on a regional level group review currently underway. Huge transformational changes were happening at central government level.
- The group plan was inconsistent with the national plan; there needed to be better synergy between the two. The review would be done through a staged plan approach, with the risk assessment being completed first. A lot had happened since the plan was last reviewed e.g. Whakaari eruption, so vastly different thinking would be brought into the new plan.
- Cabinet had provided indicative boundary proposals that would impact the region. Taupō District Council and Ngāti Tūwharetoa were represented at a workshop held that considered the proposed boundaries. The resulting feedback sent to Cabinet was to amend their proposed boundary settings for Taupō. There were some marae that sat ouside the area identified as being reliant on Turangi and Taupō for support in an emergency so the request also sought to have those marae included in the Taupō District Council boundaries. Feedback from Cabinet on those recommendations had not yet been received however once this had been received, a desktop planning exercise regarding what this would look like for various welfare agencies and organisations, and how best to service those areas, would be undertaken.
- Approximately 12 staff were deployed from Waikato CDEM to the West Coast. Very good experience; staff had showcased the region well. Feedback from the deployment had raised discussion around Covid vaccinations, in particular council, group, and NEMA expectation of those staff coming from outside the border or region to provide support in an emergency. Currently, councils could not legally require their staff to be vaccinated however, there were some specific civil defence functions where this could be required.
- Some time since Waikato CDEM had chaired CPVAG. Because of Covid, this had not been afforded the prominence that it should have; greater thought about roles and responsibilities was needed. The group plan review crossed multiple territorial authorities (TAs), and events such as the Whakaari eruption may have resulted in some TAs either wanting to do more or conversely, do less. However, there was a risk that if a TA did not fulfil their legislated mandated role and/or by default through trying to be helpful took on the obligations of another TA, if investigated, council and the group could be responsible for anything remiss under the Act. This is why the group plan needed to be more aligned with the national plan to ensure that the right processes and people were employed.

#### 4.4 NATIONAL EMERGENCY MANAGEMENT AGENCY UPDATE

Ms Suzanne Vowles introduced NEMA colleague and regional emergency management advisor (REMA) Ms Chloe Marshall, and provided a verbal update to the Committee on the work of the National Emergency Management Agency (NEMA) since the last meeting in March 2021.

During questions, answers and related discussion, the Committee raised or noted the following matters:

- NEMA capacity was increasing with a change manager recently appointed. Having 24/7 capability by the end of 2021 was big driver from the Technical Advisory Group review. Part of this role involved reviewing NEMA systems and processess.
- Amendments to the Civil Defence Act were in progress. Changes were prompted by past events with unusual components and the rewrite of the National Disaster Resilience Strategy, both of which needed

to be incorporated into the new Act. The intention was to move to a smaller Act that was supplemented by regulations, which would make any future changes much easier to incorporate. Consultation process and feedback on the changes would be undertaken before the end of this year.

- Historically NEMA and CDEM had their respective individual workplans with no real connection and understanding of overlaps or ability to harvest opportunities; a strategy was being developed to better connect both plans.
- Minister Kiritapu Allan had appointed a Māori Advisory Committee to provide guidance from a Māori perspective.

In answer to a question, Ms Vowles clarified that 24/7 capability related to awake capability and staff being available to actively monitor and respond to events as they occurred. Mr Snowball added that part of the Waikato CDEM group plan included partnering with teams that had 24/7 capability when NEMA issued warnings, with local authorities expected to ensure that information was cascaded to the relevant contacts.

The Deputy Chief Executive noted that the Taupō District Council was proactively supporting staff that chose to receive their Covid vaccinations by providing paid time off for staff to get vaccinated.

Acknowledged the work of the CD team in collating a list of vaccinated staff who would be available at short notice in the event of an emergency.

#### 4.6 CONTROLLERS' UPDATE

Mr Dylan Tahau gave a brief verbal update in relation to the controllers' role, and noted the following.

- Taupō controllers numbers were down one with the resignation of previous controller Mrs Tina Jakes.
- Further training on the RAMs programme undertaken. Mr Roger Ball had encouraged controllers to have free and frank discussions offline; local controllers had been doing this.
- Discussions with Phil Edwards regarding understanding the differences between FENZ (Rotorua / Taupō) boundaries.
- Discussions with key partners held in relation to Covid 2020 lockdown response efforts, particularly areas for improvements in future.
- Had stepped back from iwi engagement in Taupō in the hope that the group would collaborate in that space. Did not want to have a disconnect between local controllers, group, and what was happening on the national scene. In reply, Mr Snowball noted that a group project was underway to appoint a navigator or consultant to increase iwi participation at all CD levels. However, this was to address a structural system at a regional level and not intended to dilute iwi relationships at a local level. Mr Tahau appreciated the comments from Mr Snowball and clarified that given his iwi background, he wanted to highlight to the Committee that he was not an iwi controller.

#### 4.7 PUBLIC INFORMATION MANAGER'S UPDATE

The Chair introduced and welcomed the new public information manager (PIM) Nellie Dean. Ms Dean outlined her background and prior experience in CDEM both as a member of the Nelson City / Tasman District Joint Council's Emergency Management Committee where she held the CD portfolio under (then) Roger Ball, and years employment at the Earthquake Commission.

Currently there were three PIMs across the Taupō District Council, with an opportunity to increase capacity by bringing more communications advisors onboard. Prospective communication outreach included strengthening community stories, profiling portfolios, providing information on touchpoints for advice and support, and engagement opportunities.

Work on the infrastructure review across the region continued. The Wairakei transmission lines, Control Gates Bridge and power station were key concerns that compromised infrastructure resilience within the Taupō region in the event of an emergency.

The annual national Lifelines meeting was in November (in Queenstown).
