The Senior Policy Advisor informed members that after her email correspondence with them, the draft watermark was removed from the submission and was signed by His Worship the Mayor before being submitted.

She reiterated key aspects of the submission including the recommendation to shift responsibility for planning and implementation to the regional level due to limited resources for Territorial Authorities.

Members thanked Council staff for their work on the submission and in particular that they had raised landowner's concerns. The submission set out clearly how Council would like to address iwi ownership in the framework required to operate in. Engagement with all entities had been thorough, and they were continuously updated on Council's position.

They heard from the Prime Minister and some of the Cabinet Ministers, including the Minister of Local Government. The focus of discussion was around the four wellbeings and co-governance. Melissa Clark-Reynolds spoke about the future from now until 2040 in terms of technology and food supplies.

Regional planning committees were crucial to spatial planning and housing developments, and having multicultural representation in the community.
