Active Hazards & Incidents — Risk register updated to capture procedures in the event of a volcanic eruption and overall ESCC and TAA around response and readiness. Also included in the Risk Register was seismic activity and events, which is well covered in the TAA's exposition and the flow on effects of natural weather phenomenon, as was experienced during cyclone Gabrielle in 2023.

9. General Business - A questioned was raised re the no rotorcraft operations on the grass runway 10/28. Members of the ASG explained why the local rule was in place to prevent conflict with canopies. The ASG discussed the continued use of L468 to the south of the aerodrome by local operators, post deregistration of L460 by the CAA. AirNZ raised the inclusion of taxiway C added to the AIP in terms of light aircraft not using these taxiways when runway 17/35 is in use. Safety Manager to follow up as the AIP already includes this point. Ops Manager mentioned noise complaints were on the increase with housing intensification moving closer to the extended centre line of R17/35. Protection around the airport is to be included in the Taupo District Council district plan in terms of noise and the OLS. A member initiated discussion on the western helicopter lane, which may not be viable in the future due to extensive housing developments. The group agreed it was preferable to utilise the main runway as a viable alternative.
