5.2 TAUPŌ DISTRICT COUNCIL TRAFFIC CONTROL DEVICE UPDATE

The Asset Manager Transportation summarised the report and answered questions of clarification from the Committee.

In answer to a member's question, she explained the following:

In regards to the necessity of the proposed pedestrian islands on Kinloch Road, she explained that following consultation with the community, there was a demand for the pedestrian islands due to the safety of children crossing the road, and completing connection links for between the footpaths on each side of the road for the community.

She advised that the transport team were working with the developers to establish safe solutions to the areas where children were dropped off and picked up from the bus stop on Kinloch Road. Those solutions were considered when proposing the pedestrian island locations.

Kinloch Road outside 120 Kinloch Road for approx. 15m either side of Kinloch Road at island location.








Location of Proposed Road to Vest
