- 5.1 HEARINGS, DELIBERATIONS, AND ADOPTION OF ANIMAL CONTROL, DOG REGISTRATION AND FOOD LICENSING FEES

The Policy Advisor introduced himself and explained that three submitters were present in the meeting who wished to speak to the Council about their submissions. He outlined the process of the bylaw review including the pre-consultation and the special consultative procedure that was undertaken from 27 March 2024 to 3 May 2024. 139 submissions had been received in total, with 130 providing responses to

consultation on Animal Control and Dog Registration fees and 57 providing responses to the proposed Food Licensing Fees.

The following submitters spoke to their submissions and answered questions, with key points as noted below:

# #67 Mr Rob Elvin

Mr Elvin summarised his submission and encouraged the Council to consider decreasing certain Animal Control and Dog Registration fees for responsible owners with small companion dogs. He explained that small companion dogs who lived on secured properties and were microchipped should not be penalised in comparison to larger dogs with less responsible owners.

In answer to a member's question, Mr Elvin suggested that the rating system was too broad and should have allowed discounts for responsible dog owners that met certain criteria such as small companion dogs that posed less of a risk to the community.

## **#103 Ms Alexandra Walters**

Ms Walters summarised her submission. She explained to the Council how the proposed Food Licensing Fees were disproportionate and needed to be raised fairly in line with other fees.

Ms Walters discussed the potential for a lower and consistent level of increase in Dog Registration fees with a higher increase in penalties for irresponsible dog owners, rather than penalising all dog owners broadly.

## #140 Mr Gary Houghton

Mr Houghton expanded on his submission by explaining to the Council that dogs within the region who achieved the CGC (Canine Good Citizen) qualification should be eligible for a discount on certain fees as they were proven to be well behaved and owned by responsible dog owners.

Mayor David Trewavas left the meeting at this point (10.42am)

The Council discussed the various types of situations that could have had good reason for a reduction in fees such as non-working rural dogs, therapy dogs, and gold card holders with companion dogs. The Policy Advisor explained that while it was an option to reduce fees in those situations, there was possibly a large number of dog owners that fell under those categories which could have caused a significant impact on revenue.

The Council discussed the potential impact that increasing the impounding fee could have caused on all dog owners, as it would make it more difficult for owners to collect their dogs. In answer to that discussion, the Policy Advisor explained how the fees needed to incentivise owners to collect their impounded dogs, as the fees were currently lower than putting a dog in a holiday kennel park.
