5 NGĀ KAUPAPA HERE ME NGĀ WHAKATAUNGA | POLICY AND DECISION MAKING

5.1 ADOPTION AND APPROVAL OF PLAN CHANGE 38 AND 40-43 DECISIONS FOR NOTIFICATION

The Senior Policy Advisor clarified that the reporting planners made amendments to the Plan Changes throughout the hearings process and the commissioners made additional changes during deliberations. The changes listed captured all changes made throughout the entire process. If this was approved, public notification would occur 14 June and the appeal period would be through to the end of July 2024.

In answer to questions, the Senior Policy Advisor clarified the following:

- While it was preferable that new fault lines information was included in the District Plan, the plan change scope was to remove old fault lines that were incorrect. It was difficult for the panel to go beyond this but in the meantime, the subdivision process and Building Act 2004 mitigated risks to life and property. The fault lines could be revisited in the next bundle of District Plan changes.
- The removed fault lines were incorrect due to the technology at the time that they were mapped. Aerial photography had been used and was not always accurate whereas there was now advanced technology available.

Members acknowledged all of the work that had gone into the process and thanked the Senior Policy Advisor.

The Senior Funding and Partnerships Advisor summarised the report and highlighted that the policy could be refined as required.

Members supported this change to the policy because it would continue to support those individuals and groups who applied for funding to become more sustainable.

In answer to questions, the Senior Funding and Partnerships Advisor and Senior Policy Advisor clarified the following:

- No funding could be committed past three years.
- Council officers would assess the applications and provide recommendations to Council based on their assessment.

5.3 CN000527 - ROAD MAINTENANCE, RENEWAL AND NETWORK MANAGEMENT OF TAUPŌ DISTRICT COUNCIL ROAD CORRIDOR

The Team Lead Transportation Operations shared a presentation (A3559015) which gave more context and information around the new contract.

The presentation showed the parts of the complex contract and how they were important.

Cr Kirsty Trueman left the meeting at this point (2.04pm).

In answer to questions, the Team Lead Transportation Operations clarified the following:

- The incumbent supplier Inframax had chosen not to re-tender for this contract.
- The preferred contractor HEB Construction had committed to using local crews for sub-contracting, as well as local materials and resources.
- The tender also included a strong emphasis on training for youth.
- Council officers would work collaboratively with the contractor to be more proactive and refocus spending.
- Due to the delay of the Long-term Plan, the timing was not in line for the end of the current contract. The contract documentation had made it clear that there was no guarantee and it was subject to the Long-term Plan. New Zealand Transport Agency was due to provide information the same week regarding funding that would be received by councils.
- Collaboration with the contractor was successful when effort was put in by both parties. A charter would be agreed upon between both parties.

GST)], with final budget spend subject to confirmation in the 2024-2034 Long-term Plan (once adopted) and through subsequent annual plans; and that His Worship the Mayor and the Chief Executive be authorised to sign the contract documents and attach the Common Seal to them.

5.4 TAUPŌ DISTRICT COUNCIL PERFORMANCE REPORT - APRIL 2024

The Acting Chief Executive advised that much of the commentary from the General Managers was still focused on the Long-term Plan 2024-34 and that officers were looking forward to consultation and engagement events due to take place in June.

Cr Kirsty Trueman re-entered the meeting at this point via MS Teams (2.16pm).

The Senior Financial Accountant summarised the Financial Summary and Treasury Report. The Project Management Office Manager confirmed that there was another tranche of funding expected for the Tūrangi Kerb and Channel project from central Government and that the Project Manager was working hard to be able to complete as much as possible within the existing budgets.

The Project Management Office Manager presented the updated Portfolio Update report which showed more detail over the lifecycle of the projects.

The Senior Project Manager updated members on the Wairakei Drive and Huka Falls Road roundabout project. He explained that the last significant road closure would be the following week and that time delays due to Unison moving a power pole had been mitigated, this was due to be completed by the following week. He was happy with how the contractors had been performing and was pleased that they had worked with events to accommodate opening the road when events were on.

The Senior Project Manager provided an update on the Owen Delany Park upgrade project. He advised that earthworks would be commenced around the middle of June followed by the pouring of concrete. The project should be completed by the end of August 2024.

The Project Management Office Manager advised that the Taupō Airport Terminal had scored very close to gold but had been awarded a silver for the Commercial Project Awards in the Civic category.

In answer to a question, the General Manager Strategy and Environment confirmed that the Motutere Holiday Park owner Mr Tilton was being communicated with regarding the progress of his lease of the land for the Motutere Holiday Park because he was a key stakeholder.

5.6 SUBMISSION TO THE LOCAL GOVERNMENT (ELECTORAL LEGISLATION AND MĀORI WARDS AND MĀORI CONSTITUENCIES) AMENDMENT BILL SELECT COMMITTEE

The Team Leader Corporate Planning advised that the Bill was introduced to the House the previous Monday, had the first reading the previous Tuesday, and had proceeded to Select Committee with one week only allowed for submissions. Council officers had drafted a submission on behalf of members which was due to the Select Committee the following day, Wednesday 29 May 2024.

The Bill would mean that in August 2024 Council would either dissolve its Māori ward and conduct a representation review prior to the October 2025 local government elections; or would opt to keep the Māori ward for the 2025 elections. If this happened, Council would be required to hold a binding poll at the same time which determined if it would retain its Māori ward for an additional six years from 2025.

The submission focused on key points which included the positive experience of Taupō District Council since introducing a Māori ward from 2022 onwards and positive initiatives and partnership with iwi and hapū. It also highlighted that many people did not understand that the ward system (including the Māori ward) ensured proportionate representation across the Taupō District.

The Iwi and Co-Governance Manager added that the Māori ward was the only mechanism to guarantee Māori representation at the Council decision-making table. It was an additional enabler of participation and aligned with work across Council which took a partnership approach.

All members except for Cr Duncan Campbell supported the submission and congratulated officers for their work to draft it so quickly. The addition of the Māori ward councillors had added value to Taupō District Council and aligned with the practice of appointing at least one Māori representative to each of the committees of Council.

Cr Duncan Campbell abstained from voting on the basis that he did not feel there was enough information.
