## 5.1 APPROVAL TO CONSULT ON THE DRAFT MOTUTERE RECREATION RESERVE MANAGEMENT PLAN

#### TE PŪTAKE | PURPOSE

This paper seeks approval from the Motutere Recreation Reserve Management Plan Committee to commence public consultation on the draft Motutere Reserve Management Plan (RMP).

#### WHAKARĀPOPOTOTANGA MATUA | EXECUTIVE SUMMARY

Taupō District Council (Council) and Ngāti Te Rangiita hapū have been working in partnership to review the Motutere RMP. Through the initial round of community engagement in December 2023 and January 2024 we received feedback from 112 individuals and organisations. The key themes raised in this feedback have helped inform the development of the draft RMP, along with legislative changes, and changes to Taupō District Council's approach to lakeshore reserve management. This has also involved ongoing discussions with stakeholders including the campground operator, Department of Conservation, Department of Internal Affairs, Tūwharetoa Māori Trust Board and the New Zealand Transport Agency (Waka Kotahi).

At the 25 July meeting the Committee approved three key proposed changes to be included in the draft:

- Restriction of vehicle access to Ōtaiātoa Bay.
- 2. Two campground expansion areas, subject to conditions.
- 3. Reconfiguration of the Motutere Bay lakeshore lease area to include a public day-use area to the east of the boat ramp, and tent camping to the west.

We have prepared a draft management plan in accordance with this direction.

Since the July meeting, we have received further feedback from Ngāti Te Rangiita and the Department of Conservation stating their position about camping on the lakeshore. We have also received further feedback from the campground lessee expressing concern about the proposed changes. This feedback is discussed in this paper.

On approval of the draft management plan, we will proceed to the second round of formal public consultation. This will be for two months and is followed by hearings and deliberations. Once the Committee is satisfied with the final draft, we will seek recommendation to take the final draft to Council for adoption.

#### NGĀ TŪTOHUNGA | RECOMMENDATION(S)

That the Motutere Recreation Reserve Management Plan Committee directs officers to make the draft management plan and the Motutere Context Summary available to the public and call for written objections or suggestions on the draft plan, in accordance with section 41 of the Reserves Act 1977.

#### **BACKGROUND/STEPS TAKEN SO FAR**

Under Section 41 of the Reserves Act 1977 (the Act), councils are required to prepare reserve management plans for all recreation reserves for which they are the administering body. These plans should be kept under continuous review. The general practice is to undertake a review every 10 or so years. The last review for the Motutere Recreation Reserve was completed in 2004 and it is important to review the plan to ensure it meets legislative requirements and to reflect current issues, opportunities, and future aspirations.

#### Mana Whenua

Ngāti Te Rangiita, a hapū of Ngāti Tūwharetoa, are the mana whenua of Motutere and have a strong cultural and spiritual connection to the land. The review process is being undertaken in partnership with Ngāti Te Rangiita, recognising their role as kaitiaki (guardians) of Motutere and ensuring that the cultural significance of the reserve is captured appropriately.

At the governance level, the Motutere Recreation Reserve Management Plan Committee appointed for the review of this management plan includes equal representation of Ngāti Te Rangiita and Council elected

members. The committee is set up to provide direction on the management plan drafting, hear submissions and make recommendations for adoption of the plan. The final decision to adopt the management plan is with the Council's elected members.

#### **Timeline**

This summary provides a short timeline of key events of this review, so far.

26 September 2023	Council approved the establishment of the Motutere Recreation Reserve Management Plan Committee (the Committee) to oversee the Plan's development. The final adoption of the Plan is to be decided by the full Council.	
30 November 2023	Committee approved a public notice and consultation process in accordance with section 41(5) of the Act.	
4 December 2023 - 15 January 2024	Public consultation period.	
15 February 2024	Feedback received in the public consultation period presented to the Committee in a workshop.	
21 March 2024	Committee workshop to discuss issues and options for the reserve.	
2 May 2024	Committee workshop where feedback was provided on the draft RMP and vision statement.	
30 May 2024	Committee workshop to provide further direction on the draft; lessee presented his proposed masterplan for the campground.	
25 July 2024	Committee meeting to provide direction on the draft reserve management plan and concept plan for consultation.	

#### NGĀ KŌRERORERO | DISCUSSION

The first round of consultation took place over December 2023 to January 2024 for a period of six weeks. 112 submissions were received. Key themes emerged through this review which informs a set of objectives, outcomes, and actions for the Plan. The themes included:

- Pedestrian safety crossing the State Highway
- Differing views on whether camping should be enabled on the lakefront part of the reserve.
- Not clear where boat trailer and car parking is.
- Unsafe swimming activities occurring next to the jetty and boat ramp.
- No clear public access to the Motutere Bay lakefront.
- Illegal camping, fly tipping and offensive behaviour occurring at Ōtaiātoa Bay.
- Environmental degradation and erosion occurring on the lakeshore.
- Reduction in native flora and fauna.
- Memorable history of the Motutere Campground from campers.

The feedback received from the consultation period helped the committee develop the draft vision statement for Motutere reserve:

The mauri (life essence) of Motutere and its taonga (values) are protected and restored, the rights of mana whenua are recognised and provided for, and the recreation reserve continues to be a place for people to share and enjoy.

Six objectives have been drafted:

- 1. Mana whenua cultural values are respected and celebrated.
- 2. The reserve's unique natural values are protected and restored.
- 3. Public access and associated safety are maintained and enhanced.
- 4. Recreational values are maintained and enhanced.
- 5. Built structures are sensitively designed to integrate with the natural values of the reserve.
- 6. Leases and licences are provided for where they enhance recreation values.

The draft RMP is supported by two other documents:

1. Reserve Management Plan

Provides the draft vision, values, key objectives, outcomes, management concept plan, and actions for the Motutere Reserve for the next 10 years. This is what we are seeking feedback on.

2. Motutere Context Summary

This outlines the key information that has been considered in the development of the Plan, along with a glossary of terms. This is intended to help inform the community but doesn't form part of the formal RMP.

3. Implementation Plan

This outlines an operations workplan to implement the actions in the Plan. This will be a living document that will be amended through the Long-term Plan and Annual Plan process where Council identifies work priorities and allocates funding. This document will be prepared once the direction in the RMP has been set.

#### **Recommended Changes to the 2004 Plan**

The review of the 2004 RMP has been comprehensive to ensure legislation, Taupō District Council's current approach to lakeshore reserve management, and mana whenua and community aspirations, are all reflected in the draft plan.

Three significant proposed changes were presented at the 25 July 2024 Committee meeting, to seek direction on which option to consult on:

- Restriction of Vehicle access to Ōtaiātoa Bay.
- 2. Two proposed campground expansion areas.
- 3. Reconfiguration of the Motutere Bay lakeshore lease area.

The papers and the committee decisions are detailed below.

#### Restriction of Vehicle Access to Ōtaiātoa Bay

Ōtaiātoa Bay foreshore reserve is not adequately providing for public lakeside recreation as an alternative to Motutere Bay. Access off the State Highway is unsafe. The internal access road is in poor condition, there are no water or wastewater services, there have also been reports of illegal camping, dumping and offensive behaviour occurring on this part of the reserve.

The Committee resolved to consult on the proposed option to restrict vehicle access to Ōtaiātoa Bay, to better provide for public use and enjoyment, and help restore the natural character values of the bay.

#### **Proposed Camping Expansion Areas**

Two camp expansion areas were proposed in the 2004 RMP:

- 1. Camp Expansion Area Tourist Accommodation
- 2. Camp Expansion Area Active Recreation

It was anticipated that any proposal to develop these two areas would be supported by a Development Concept Plan.

During this RMP review further assessments have been undertaken to determine the suitability of the two proposed sites for expansion. These assessments include an Ecological Report and a Cultural Values Report. The reports show that parts of the Motutere Recreation Reserve and surrounding areas have ecological and cultural significance.

The Committee resolved to include both areas in the draft RMP, subject to conditions. These conditions are included in the draft RMP. In the draft RMP and Reserve Management Concept Plan the areas are now identified as Proposed Campground Area 1 and Proposed Campground Area 2.

The intention was for Proposed Campground Area 1 to be used as an "off-set" area for the campground lease when camping is removed from part of the lakeshore. This was not explicitly resolved at the 25 July meeting. We are now asking the Committee whether they would like to see an additional condition for Proposed Campground Area 1 to make clear that this area is enabled only if there is a corresponding reduction in lakeshore camping.

At this point the draft RMP signals that proposals to develop Area 1 will need to show how the ecological impacts will be managed. The RMP also suggests that a cultural impact assessment would be required. We appreciate that this leaves some uncertainty for the campground operator. We are working with the hapū representatives to provide more detail on exactly what level of change might trigger such an assessment and what it would need to address. This further detail can be further considered as part of the deliberations process.

#### Configuration of the Motutere Bay Lakeshore Lease Area

Through the review process, concerns have been raised about the balance between the parts of the reserve that are set aside for commercial camping versus the areas available for the community to access.

Initially the campground catered only to tents but over time the lakeshore lease area has expanded to include permanent caravans, domes, and motor homes. This transformation has led to issues with safety, erosion, traffic, and access to the boat ramp. Additionally, the exclusivity of the current campground operation has significantly limited public access to Motutere Bay.

The Committee was presented with three options for the lakefront: maintaining the status quo, no camping, or allowing shared use of the lakeshore. The Committee resolved to consult on a reconfigured lakeshore that would include a public day-use area to the east of the boat ramp and tent camping remaining to the west of the boat ramp.

#### Feedback Since 25 July Meeting

After the Committee meeting, staff received further informal feedback from Ngāti Te Rangiita, the Department of Conservation, and the lessee. Below is what was received from each group.

#### Ngāti Te Rangiita

A Ngāti Te Rangiita representative informed Council staff that the hapū recognise that change in the way the lakefront area is used would require a transition period. However, they want to see a clear date by which all camping on the lakefront would cease (Attachment 3).

#### The Department of Conservation (DoC)

DoC are the owners of the Motutere Reserve, they also manage the adjacent scenic reserve and therefore have a vested interest in the RMP. During past conversations with Council, DoC have expressed concerns about camping on the lakeshore. They have further clarified their position as:

"The view the Department holds is largely unchanged since our previous engagement back in July 2001. In respect to the current lease agreement, the department is not in support of exclusive commercialisation of Crown held land which holds significant cultural and recreation values, such as the lakefront. Our preference for the long term is definitely for <u>no</u> camping on the foreshore. If that is achievable within the current lease then all the better, but the department would ultimately like to see the entire lakefront portion of the reserve available for unrestricted, non-commercial public use.

As per our previous statements, the department is supportive of the removal of permanent infrastructure and caravans from the lakeside reserve, increased opportunities for enhanced public access, and restoration of native vegetation at place to enhance the visitor experience. The department would support any move to step back the camping activity on the lakefront during the lifetime of the current lease."

#### Campground Lessee

The current campground lessee, Mr John Tilton, has expressed his discontent with the paper presented to the Committee and with the option that the Committee approved for consultation. He wanted to restate to the Committee that the campground has been in place for over 70 years, is highly valued by visitors both internationally and nationally, and has welcomed generations of families to Motutere. He has emphasised that feedback from campground patrons overwhelmingly requested that the campground remain unchanged. He has also noted:

- It contributes greatly to the local economy and helps to promote the district.
- It contributes to New Zealand's standing as a beautiful tourist destination with amazing landscapes and has a 4.3 rating on Google.
- It is the last remaining campground on the lake that enables visitors to have a lakeside experience.
- It is common in other parts of the country to have waterfront camping.
- He has spent approximately \$1.5 million over the past seven years on infrastructure on the waterfront. Investment within the Holiday Park was one of the conditions for Overseas Investment Office (OIO) approval that enabled him to purchase the lease. Closure of the lakeshore to camping would effectively make the waterfront investment obsolete.

He has a clear preference to retain camping on the lakefront as it currently is, however, he has also acknowledged that there is room for a compromise. During discussions on 21 August with officers he explained that rather than the RMP setting a firm date for camping on the lakefront to stop, he could accept the RMP allowing tent camping as directed by the Committee at the 25 July meeting. In recognition of the hapū concerns, he could support a new 33-year lease that enables camping on the lakefront until at least 2038 (14 years), and thereafter recognises that camping on the lakefront must cease if directed by a future review of the reserve management plan. This approach is intended to enable a 33-year lease to be signed soon with the option of camping on the lakefront ceasing at some point beyond 2038 if the administering body makes that future decision.

#### Proposed Changes to Draft RMP and Consultation Material to Reflect Further Feedback

It is important to note that there is no proposal to close the entire campground and officers will make sure consultation material reiterates this point. The draft RMP proposes reconfiguration of camping on the lakeshore to better reflect and protect environmental and cultural values. The area of the lakeshore proposed to be closed to camping is approximately 0.8 hectares, however in recognition of that loss of camping area the RMP provides Proposed Expansion Area 1 which has potential for 1.5 hectares of new campground area. Proposed Expansion Area 2 may provide further recreational options for the campground.

We have prepared the draft RMP in accordance with the direction that the Committee gave at the meeting on 25 July. The draft currently signals that the lakeshore area will be split into a day use area and a camping area for tents. If the committee wishes to signal that all camping will ultimately be removed at a point in the future, officers can provide alternative wording for the draft RMP.

#### **Motutere Context Summary Document & Implementation Workplan**

The Motutere Context Summary sets out the background information for the development of the Plan. It outlines the processes involved in developing the management plan, key considerations, values, features, safety risks, legal descriptions and key documents that have informed the plan. While this will be included in the consultation package, it does not need to be formally adopted with the management plan. This allows flexibility when amending the document in the future.

An implementation workplan will also be developed once actions are confirmed. This will set out the actions in detail including who will implement the action, timeframes, and resource.

#### **Next steps**

The second round of consultation will invite feedback on the draft document, submitters will have the opportunity to submit on the six objectives, the three main proposed changes, and the entire draft Reserve Management Plan.

The consultation period will be open for two calendar months. If the Committee agree to begin consultation now, a public notice will be advertised in the New Zealand Herald on 31 August 2024, meaning submissions would close on 31 October 2024. We will also advise all those who made submissions through the consultation period at the start of the review process that there is an opportunity to comment on the draft.

There will be two organised engagement sessions throughout the consultation period where the public can speak to the Committee members and staff regarding the draft RMP. Staff will also be available for individual conversations with members of the community throughout the consultation period.

The Committee will receive and hear all feedback through a formal hearing and make recommendations to Council on the draft RMP. The draft will then be presented to Taupō District Council Elected Members for the final adoption.

A copy of the draft RMP and the Context Summary report is attached to this report.

#### NGĀ KŌWHIRINGA | OPTIONS

Based on this information it is considered that there are three options.

#### **Analysis of Options**

#### Option 1.

Delay consultation and direct officers to undertake further work on the draft Motutere Recreation Reserve Management Plan.

#### Analysis Conclusion:

At this point option 1 seems inappropriate given there do not appear to be any outstanding matters that the Committee need to address. Option 2 aligns with the Committee's direction to date, however there is the potential for the Committee to make some editorial changes to the draft RMP. If those can be resolved at the meeting, we will still be able to progress with the planned consultation. Either way, officers recommend that the Committee approve a draft for consultation to enable certainty about the future management approach of the reserve.

#### NGĀ HĪRAUNGA | CONSIDERATIONS

#### Ngā Aronga Pūtea | Financial Considerations

There is no direct financial impact from the formal consultation period. The consultation period has been provided for in existing budgets.

The draft RMP proposes changes to the reserve that will require Council funding in the future. Those funding decisions will need to be made in the context of either an annual plan or a long-term plan.

#### Ngā Aronga Ture | Legal Considerations

#### Local Government Act 2002

The matter comes within scope of the Council's lawful powers, including satisfying the purpose statement of Section 10 of the Local Government Act 2002. That section of the Act states that the purpose of local government is (a) to enable democratic local decision-making and action by, and on behalf of, communities; and (b) to promote the social, economic, environmental, and cultural well-being of communities in the present and for the future. It is considered that social, economic, environmental, and cultural are of relevance to this particular matter.

The proposal has been evaluated with regards to a range of legislation. The key legislation applicable to the proposal has been reviewed and the relevant matters for consideration are as follows:

#### Reserves Act 1977

Taupō District Council is the administering body of the Motutere Recreation Reserve under the Reserves Act 1977. Under section 41 of the Reserves Act Council is required to have a management plan for the Reserve which shall be kept under continuous review so that the plan is adapted to changing circumstances or in accordance with increased knowledge.

The Motutere Recreation Reserve Management Plan Committee have delegation to oversee the review. The committee can approve the draft reserve management plan for consultation and make recommendations to Council who will adopt the final plan.

All decisions must be consistent with the purposes of the Reserves Act 1977, as set out in section 3. The Reserves Act requires a two-month consultation period on the draft RMP and then the opportunity for submitters to present to the Committee.

The review of the Reserve Management Plan will be in accordance with the Reserves Act 1977.

#### Ngā Hīraunga Kaupapa Here | Policy Implications

The key aspects for consideration with regards to this proposal are as follows:

The existing reserve management plan was developed in 2004 and this review process ensures the ongoing management direction remains relevant.

#### Te Kōrero tahi ki te Māori | Māori Engagement

Taupō District Council is committed to meeting its statutory Tiriti O Waitangi obligations and acknowledges partnership as the basis of Te Tiriti. Council has a responsibility to act reasonably and in good faith to reflect the partnership relationship, and to give effect to the principles of Te Tiriti. These principles include, but are not limited to the protection of Māori rights, enabling Māori participation in Council processes and having rangatiratanga over tāonga.

Our statutory obligations outline our duties to engage with Māori and enable participation in Council processes. Alongside this, we recognise the need to work side by side with iwi, and hapū of our district.

This review is being undertaken in partnership with Ngāti Te Rangiita, mana whenua of Motutere. The hapū has an active role in the project team with a codesign approach. Hapū representatives are also included in this Committee overseeing the review of the Reserve Management Plan.

A cultural values report for the Motutere area including the reserve has been undertaken by Herea Winitana of Ōtaiātoa Ltd on behalf of Ngāti Te Rangiita.

Council received a letter from the hapū on 12 August 2024 (attachment 3). This letter outlines the hapū's preference for no camping on the Motutere Bay lakefront. They state in the letter "Ngāti Te Rangiita are strongly of the view that the draft RMP for consultation should signal in clear outcome-focused terms that, after the expiry of the existing lease, there is to be no lakefront camping."

Hapū will also have an opportunity to make a submission on the draft RMP.

#### Ngā Tūraru | Risks

The draft RMP signals the creation of a new day use area on the lakefront and the restriction of vehicle access to parts of the reserve. Those changes will require significant Council investment, however the timing of that is currently unknown. There is a reputational risk to Council of making changes too far in advance of that investment. For example, removing camping off part of the lakefront but significantly delaying the investment to create an accessible and attractive day use area could create frustration.

There is an existing campground lease in place that provides rights to the lessee. If that lease is not able to be renegotiated Council may not be able to make some of the proposed changes in the draft RMP until the lease expires in 2038.

Further delays to the consultation process are likely to mean that Council will not be able to adopt the management plan until 2025. That is likely to lead to delays in starting the next reserve management plan process in Tūrangi.

Further delays are also likely to cause frustration for the Community and particularly the campground lessee. They are all seeking certainty on the future management direction for the reserve. At this point the renegotiation of a lease for the campground is waiting on clear direction from the management plan.

#### TE HIRANGA O TE WHAKATAU, TE TONO RĀNEI | SIGNIFICANCE OF THE DECISION OR PROPOSAL

Council's Significance and Engagement Policy identifies matters to be taken into account when assessing the degree of significance of proposals and decisions.

Officers have undertaken an assessment of the matters in the <u>Significance and Engagement Policy (2022)</u>, and are of the opinion that the proposal under consideration is significant. The review of the management plan is of high interest to the local community, campers, the hapū and lessee of the Motutere Bay Top 10 Holiday Park.

#### TE KŌRERO TAHI | ENGAGEMENT

Once the draft plan has been prepared, the community will have an opportunity to provide their views during the formal submission period. This is expected to be between 31 August and 31 October 2024. This will be followed by hearings and deliberations by the Committee.

Once the Committee has approved a draft for consultation officers will notify all submitters about the formal submission dates and process. There will also be open days, planned for the campground, where the community can ask questions.

#### TE WHAKAWHITI KŌRERO PĀPAHO | COMMUNICATION/MEDIA

A communications plan has been prepared in consultation with the communications team. Direct communication will be carried out with affected stakeholders and wider communication will be carried out with the community. A summary communications and engagement plan is attached (Attachment 4)).

#### WHAKAKAPINGA | CONCLUSION

The attached draft RMP reflects the direction from the Committee. Taupō District Council and Ngāti Te Rangiita hapū have been working in partnership to review the Motutere RMP. While the hapu representatives are supportive of most of the draft RMP, it is important to note that they would like to see a definitive date when camping on the lakeshore will cease.

Once the Committee approves the draft management plan, we will proceed to the second round of public consultation. This will be for two months and is followed by hearings and deliberations. Once the Committee is happy with the final draft, we will seek a recommendation to take the final draft to Council for adoption.
