
Operations update

There will be a verbal briefing given to members at the meeting to include the following:

- Council's water mains project which consisted of the rerouting of the existing Airport service has been completed including tidy-up works and grassing of areas affected.
- The terminal automated door near the check-in counters has had an issue with the sliding doors making a grinding noise when opening and closing. The carriage wheel has been replaced which has alleviated the issue.
- As per the Airport Management Action Plan and in compliance with the Airport's Aerodrome Operating Certificate, an Obstacle Limitation Survey is due during 2025 and has been budgeted for in the forthcoming financial year.
- TAA management has been advised of a wasp nest by a tenant on a landside area adjacent to the fence line. A local pest control company has been contacted, and the nest has been removed.
- The power amperage for one of the terminal electricity circuits has been increased as the hand dryers in the toilet block kept tripping the power when in use. This has cured the issue.
- TAA management is working with the Council's risk advisor on the Taupō Airport's business continuity plan. This exercise is capturing all of the business units across the Council.
- The quarterly aerodrome inspection was completed on 10 March 2025. It was noted that the pilot gate at the aeroclub was not latching correctly, and this has been raised with the aeroclub for action. Further items that were raised during the inspection are dealt with as part of other reports in the agenda.
- The Emergency Services Coordinated Committee meeting was held on 18 March 2025 and was attended by TAA management.
- The annual TAA management review was conducted on 2 April.
- The Airport's operating exposition suite has been fully reviewed by TAA management and all three manuals will be reissued in conjunction with the review. Digital copies will be forwarded to recipients according to the distribution lists.

Passengers and aircraft movements

Passenger numbers per month (January 2023 to March 2025)



Members will be aware Sounds Air Travel and Tourism withdrew their air service from Taupō to Wellington at the end of 2024 due to declining passenger numbers and having to consolidate their operations.

Following successful discussions between management and Nelson-based airline Originair, a new sixmonth trial service between Taupō and Wellington commenced on Monday 17 February. The new service is currently operating three days per week on Monday, Wednesday and Friday utilising the airline's 18 seater British Aerospace Jetstream aircraft.

The service is timed to link into the airline's flights from Wellington to Nelson and Westport creating two links into the South Island. The service into Nelson is on the same aircraft with a 30 minute transit time in Wellington.

Management recently met with Originair's Chief Financial Officer and was informed that the service is going as expected with loadings looking good for a new start-up operation and that the opportunity to expand the service to more than three days per week with a possible change in timings is being explored.

5.4 TAUPŌ AIRPORT AUTHORITY CAPITAL PROJECTS UPDATE

TE PŪTAKE | PURPOSE

For the General Manager Taupō Airport to provide a capital projects update to the committee.

NGĀ KŌRERORERO | DISCUSSION

Apron extension

The project to construct a 3,100m2 extension with asphalt surfacing to the existing apron, complete with ground lighting and revised aircraft guidance markings, has been completed within budget and more or less on time. The work was carried out by Fulton Hogan Limited with Airways New Zealand installing new electric cabling and apron edge lighting.

The new aircraft parking area (Gate 5) is being utilised by the larger jet charter traffic with Gate 4 now being reserved for smaller aircraft.

There is still some tidy-up required to the grassed areas surrounding the extension which will be carried out by the Airport's ground maintenance contractor in due course.

Apron surface treatment

Another major project was also completed in mid-March – the surface treatment to the northern and southern apron areas along with taxiway Delta.

The project was carried out by HEB Construction and consisted of crack sealing to the existing surface followed by a two-coat surface treatment with a proprietary product called SteelGuard XL to an area of approximately 16,000m2. The treatment coats the area with a flexible membrane, sealing the surface and creating a waterproof layer – the surface treatment should extend the life of the apron by between five and eight years.

The project was completed on budget but ran over on time due to mechanical breakdown of the contractor's plant and equipment.

Following this work, the whole apron was remarked with a new design for aircraft guidance, parking and to improve clearances. There are now five aircraft stands with Gates 1 and 2 for commercial traffic, Gate 3 for smaller itinerant aircraft and Gates 4 and 5 for the jet charters.

The Ministry of Transport has agreed to fund 50% of the works as it is deemed to be essential for compliance with the Airport's Aerodrome Operator Certificate.

Reconstruction of the Jet A1 refuelling area

A third apron project has also been completed during the apron extension works – the reconstruction of the aircraft parking area to the northern Jet A1 fuelling area.

This was completed at this time to take advantage of the contract rates for the apron extension and, with the contractor already established on site, realised an approximate 30% saving on a standalone project.

The Ministry of Transport has agreed to fund 50% of the works as it is deemed to be essential for compliance with the Airport's Aerodrome Operator Certificate.

All three projects have been rolled into one larger project called the Taupō Airport Apron Redevelopment Works and will be submitted to the 2025 New Zealand Airports Association airport awards later in the year.

Boundary fencing

The first stage of a three-year rolling programme to renew the Airport boundary fence and installation of upgraded security gates has been completed. This stage was to replace the southern boundary fence and also install a new automatic vehicular gate to give controlled access from landside to airside onto the southern apron.

The southern boundary fence is a shared boundary, being jointly owned by TAA and Taupō District Council (TDC), and an agreement was reached with each owner paying an equal share for the works.

Due to the contractor encountering rock when excavating fence post holes the initial quote increased, however, both TAA and TDC accepted the additional costs.

The Ministry of Transport has agreed to fund 50% of the TAA's costs as it is deemed to be essential for compliance with the Airport's Aerodrome Operator Certificate.

Even though Taupō Airport is not designated as a Tier 2 airport under Civil Aviation Authority rules, with the new security gate being installed and the fencing and controlled access work previously carried out when the new terminal was constructed, the Airport is working towards Tier 2 security status in the vicinity of the terminal. A Tier 2 airport is one with enhanced security and Aviation Security introduced measures a few years ago to improve security in the vicinity of the terminal including passenger screening. The idea was that aircraft with 30 seats or more would require the passengers to be screened prior to boarding, however, as Taupō at the time only had 19-seater aircraft, the airport was not included and was classed as a Tier 3 airport.

If screening was to be introduced in the future and with Taupō having 50-seater aircraft, we would need to introduce the addition security measures. The new terminal had been designed with screening being a possibility, so it made sense to also upgrade the fencing to Tier 2 standards as well. We also considered this to be essential to control and prevent unauthorised access to the apron now that we have a larger number of private jet charters at the airport.

A notice of requirement and private plan change has now been lodged with Council to the District Plan to cover forecasted aviation growth over the next 30 years.

The purpose is to set in place an appropriate and efficient planning method within the Taupō District Plan.

This will provide for the ongoing use and development of the Airport land and infrastructure whilst seeking to provide recognition and controls in the Plan in a way that appropriately recognises the specific development and operational needs of a regional airport.

The lodgement was submitted on 25 February 2025 and will be subject to public consultation.

NGĀ KŌRERORERO | DISCUSSION

Taupō Airport Authority (TAA) is the name given to the Joint Venture (JV) relationship between Taupō District Council (TDC) and the Ministry of Transport (MoT), representing the New Zealand Government, under a Deed drafted in 1973. Each partner has a 50% share in the JV and TAA is entrusted to manage the Airport operations on behalf of the JV partners.

There are five JV airports:

- Taupō
- Westport
- Whakatāne
- Whanganui
- Whangārei

The Ministry had signalled that the agreements with all of the five JV airports require to be updated to bring them more in line with modern aviation practices, however, the process has stalled and at this stage no further work is planned by the MoT.

According to the 1973 Deed, there is a clause which relates to all new airport leases/licences that have to be reviewed and agreed by the Ministry. This clause has been disputed in the past by the five JV airports and, consequently, this has not been strictly adhered to when new leases/licences have commenced.

However, now that JV airports are included in the portfolio of the associate Minister of Transport, Honourable James Meager, management has been notified that there will be a requirement to forward all new leases/licences to the Ministry for review and approval.

Management has suggested that a monetary threshold be applied before the MoT need to be involved and whether consideration is also given as to whether the lease/licence is required for operational needs in compliance with Civil Aviation Authority Part 139.

In the meantime, a current draft lease agreement that management is dealing with has been forwarded to the Ministry for review.
