A meeting may deal with (i.e. make a resolution in respect of) an item of business not on the agenda only if the procedures set out in Standing Order 9.12 are followed.

- The team are looking into further yellow line making and would appreciate photos/feedback from the Kinloch Representative Group on specific areas.

Poplar Incident Update

The Team Leader for Transport will provide an update.

Kinloch Marina Footbridge

Two weeks of work on abutments stabilisation was completed in the first week of April. Anti-slip matting is planned to be renewed around July/August of next financial year.

Annual Plan 2025-26

The Policy Advisor will provide a verbal update on Annual Plan 2025-26.

Dogs and Bylaws

The Policy Advisor and Compliance Manager will provide a response to questions from the previous meeting about how the Dog Control Bylaw works and process for when a review may occur to test options for addressing concerns raised by the community.

Classification of Reserves

We've identified that several recreation reserves in Kinloch that are vested in Council have not yet been formally classified under the Reserves Act. A report will be presented to Council on 29 April 2025 to address this.

An additional report will be presented to the Taupō Reserves & Roading Committee seeking approval to consult on a proposed reclassification of part of one reserve to Local Purpose Reserve, to support water services delivery.

Further details about the proposed reclassification, water infrastructure plans, and the public submission process will be provided to the Committee in due course.
