5 NGĀ RIPOATA | REPORTS

5.1 APRIL 2025 - TAUPŌ AND TAUPŌ EAST RURAL COMMUNITY FUND DISTRIBUTION

The Senior Funding and Partnerships Advisor thanked those that had attended the meeting, and applied for funding. She reiterated that the committee had \$150K to distribute as per the report, and that applications had been scored according to the Community Funding Eligibility and Assessment Framework as shown in the Application and Assessment Summary attached to the agenda.

Applicants present at the meeting introduced themselves to the committee and answered questions:

#6 Awhina Society Trust - Ms Simone Gibson

Ms Gibson clarified the following:

- There had been a large increase in people using the service over the previous 12 months.
- Funding and support from Council was needed because there was a lot of demand from the community for food parcels to individuals and also organisations.
- The Trust was growing food rescue operations.
- The Trust operated in a different way to the other Taupō foodbank in that it offered a week's worth of three meals per person per day. The Trust did share resources with the other foodbank.

#10 Taupō Budget Advisory Service Inc - Ms Rebecca Robertson

Ms Robertson advised that demand for the service had increased over the previous 12 months.

#54 The Royal New Zealand Society for the Prevention of Cruelty to Animals (SPCA) – Ms Donna Urguhart

Ms Urquhart confirmed that the SPCA worked with CARE by sharing resources to collect animals and sharing foster parents for animals.

#31 Taupō Community Gardens

The following was confirmed:

- Anti-social behaviour had been mitigated by increasing the hours when people were onsite, and installing cameras. Signage explained the purpose of the gardens and the damage had stopped.
- New people were joining all the time and there was now a cross section and spread of ages for future proofing and succession planning.
- The Taupō Community Gardens had a relationship with Budget House and local schools and worked well with them.
- The Taupō Community Gardens collaborated with a community garden in Nukuhau and gave any excess products to them on Mondays. They also shared compost equipment.

#22 Kinloch Village Golf Club Incorporated - Ms Carolyn Hedley

Ms Hedley confirmed that the Kinloch Village Golf Club was a community facility and well used. A local group used it once per week, and a farmer's group used it regularly. Membership at the golf club had risen to over 400 members.

#13 REAL Southern Lakes - Ms Olivia Beck

Ms Beck confirmed that events had been run before and were successful so with additional funding, they would be done better. She confirmed that REAL Taupō and Southern Lakes were the same organisation and operated district wide.

#11 Taupō Timebank - Mr Blair Cameron

Mr Cameron explained that there were 2 different age groups for the Upskillz programme and that they worked with schools, groups and homeschools. They taught them how to build things, giving them the experience of using tools and gardening. By the end of 3 or 4 lessons they would have built a garden bed and planted it with vegetables. Some went home and built garden beds for family members. Tools were provided to those attending workshops to build garden beds and Taupō Timebank was supported by Mitre 10 and roofing industries for materials.

#3 Towncentre Taupō - Ms Julie McLeod and Mr Ken Harris

Ms McLeod and Mr Harris confirmed that there was a mixture of new art and replacement art each year. Art students were not usually able to participate due to the timing with exams but some that volunteered went on to become artists.

#7 Taupō Disc Golf Club - Mr Ken Harris

Mr Harris confirmed that it was hard to know the numbers using the disc golf course because while there was an app, only some used this. Since 2021 when the course opened there had been events organised which drew more interest. The shared space with dog walkers worked really well and club members called out bad behaviour if they saw it.

Cr Christine Rankin entered the meeting at this point (11.21am).

Mr Harris confirmed that the Club were interested in adding a pitch and putt course near Nuki's Gym for practising and learning the game. The Club was in discussions with Council's Parks and Reservs team regarding this.

#27 Centre Stage Taupō Inc - Ms Kylie Dumble

Ms Dumble explained that a hazer created texture in the air and lighting changes for theatrical and musical events to create interesting effects.

#23 Taupō Community Playgroup - Ms Vera Spurdle

Ms Spurdle explained that the playgroup was aiming to improve accessibility of the toilets for the small children to use them independently. This would mean smaller toilets and push taps. The work was being done in stages and the timing meant that the flooring needed to be replaced. Funding had been received from the Ministry of Education but it did not cover the entire project.

#15 Wairakei Community Group - Ms Rachel Canning and Ms Vera Spurdle

Ms Canning and Ms Spurdle explained that this group was trying to create a connected community with community spirit and make Wairakei village a more enjoyable place to live. The group collaborated with Kids Greening Taupō on some projects.

#35 24/7 Youth Work - Ms Caitlin Hodges

Ms Hodges clarified that she would work with REAL Southern Lakes and Anamata to support what they were doing already for youth. The funding requested was to support Taupō-nui-a-Tia with a youth worker.

#4 Life Education Trust Central Plateau - Ms Robyn King

Ms King clarified that the Trust visited over 1600 children from ten schools in the local Taupō region. 85% of schools in the region had a visit either annually or biannually – they could not fit all schools in with one educator and the timetable.

#41 Kian Weston - Mr Greg Weston

Mr Weston introduced himself and explained that he was Kian's father. He had been competing in a three part youth series for triathlons and finished 2nd overall. He was selected to go to a competition and the

funding requested was to support that.

#36 Volcanic Dive Squad - Ms Sharon Graham

Ms Graham confirmed that the squad operated in Lake Taupō but occasionally went to Rotorua or Wellington for assistance with clean up dives. The squad did not charge for finding lost items but sometimes were given a koha as thanks.

#56 Taupō Lakes and Waterways - Ms Natalie Haines

Ms Haines thanked Council for funding in the previous years.

The purpose of this document is to support you and your fellow committee members to make decisions when allocating Taupō District Council's (TDC) one – off community funds.

This document will be provided to decision-making committees to outline what funds are available and the process taken to distribute funding.


Background

Council decides to allocate a budget to its community funding programme every three years, as part of its long – term planning process.

During this process, Council also adopts a funding policy and eligibility assessment framework to guide what types of contestable funds are available for communities, their purpose, and how applications will be considered, assessed, and prioritised. These documents are reviewed every six years, or as otherwise decided by Elected Members.

The Community Funding Policy (2024) and Community Funding Eligibility and Assessment Framework (2024) were last adopted on 1 August 2024. Both documents are available to view at **Taupō.govt.nz/grants**.

What types of funds are available?

1. Strategic Partnership Fund

The strategic partnership fund is a multi-year contestable fund that can be accessed by community groups or organisations who will support Council to achieve key strategic outcomes and/or provide advice on business — as — usual activities, programmes, and projects.

2. Accelerator Fund

The accelerator fund is a multi – year contestable fund that can be accessed by community groups or organisations who would like additional support to grow what they do, achieve their aspirations and build vibrant and thriving communities. The fund provides financial and in-kind support from Council over three years, as part of this recipients are expected to develop long term planning practices, and develop governance and diversified funding approaches for long term sustainability.



\$160,000 per annum excl GST (\$20,000 per annum excl GST per agreement).



Elected Members decide on accelerator fund recipients and amounts following the long – term plan process.

3. Community Grant Funds

Community grant funds are one-off contestable funds of up to \$5,000 excl GST to support community-led events, projects, and initiatives. Community groups, organisations and even individuals may apply to these funds. There are three funds split across Taupō District Council Wards.

\$40,000 excl GST available for the Mangakino Pouakani Fund annually.

Funding Priorities

Council's vision is for the Taupō district to be "a district of connected communities who thrive and embrace opportunities" and Elected Members have set five community outcomes to improve the social, economic, cultural, and environmental wellbeing of our communities.

During the application process, we ask applicants to demonstrate how their request aligns to at least one of these outcomes (funding priorities). The assessment summary decision makers receive will outline what funding priority (or priorities) the application aligns to.

Application Process



1. Accept Applications

Applications for community funds are accepted at different times:

- Strategic Partnership Fund every three years, following adoption of Council's long term plan.
- Accelerator Fund every three years, following adoption of Council's long term plan.
- Community Grant Funds twice per year, typically six months apart.

All applications are submitted through the website at www.Taupō.govt.nz/grants.

The opening and closing dates for each fund are advertised through our website, social media, in TDC newsletters, newspaper and community – led communications. We also encourage committee members to promote funds through their networks.

Please note: In future, Council will have a centralised platform to accept, assess, decide on, and notify applicants about their request. In future, this will be the place decision makers log into to view applications ahead of decision meetings. The funding and partnerships team will provide training on how to use the system when this occurs.

2. Assess, prioritise, and recommend applications

Applications are assessed for eligibility and considered by council officers against the policy and eligibility and assessment framework. Recommendations on priority applications will be provided in an assessment summary for decision makers.

An assessment method is used to ensure a transparent and equitable approach to community funding decision making. All applicants have access to the scoring criteria to support them when making an application.

Please note:

 This assessment is based on the eligibility and assessment framework Council adopted in August 2024. Further detail around what assessors consider when assessing applications is included as appendix one.

- If an accountability report for a previous grant has not been submitted by the date of the
 allocation meeting, the application is not eligible to receive funding. If this applies to any
 applicants, an update will be provided at the decision meeting.
- If an applicant is already receiving another community fund through Council, this will be noted in the assessor comments.
- All applicants have access to the scoring criteria during the application process to support them in making an application.

3. Funds are allocated

Your role as a community funding decision maker...

- Is to work impartially as part of a committee to consider and allocate Council's community funds impartially.
- You will receive a copy of all applications, and an assessment summary to prepare ahead of each decision meeting.
- You will be asked to declare any conflicts of interest at the beginning of every allocation meeting.
- Where it is decided that an application will be declined, we ask decision makers to provide rationale as to why this decision has been made. This allows officers to provide support to declined applicants and where possible ensure they have the opportunity to improve on any future applications they make.

Who may attend a fund allocation meeting?

- The public. Applications are considered in an open forum we ask committees to welcome
 those who wish to listen to the meeting. At the time of making an application, applicants
 may choose whether they would like to be present to answer any questions of clarification
 during the decision-making process.
- Elected Members. Where committees of Council make decisions, those elected members who do not sit on the decision-making committee are able to attend the meeting with nonvoting rights.
- TDC officers. Will be present at allocation meetings with non-voting rights. Officers are
 available for policy or eligibility queries, to provide further context, and to ensure a
 consistent process is upheld.

Appendix One – Assessment Framework

The below table outlines the assessment framework officers use when assessing and recommending priority of applications received to the one – off community funds.

	Considerations	Scoring Weight (partial scores may be provided)
Project/ activity purpose	Has the applicant clearly defined the purpose and expected community outcomes and benefit the project, activity or service will provide? Has the applicant clearly outlined the community need that is being met and why this is important?	1
Strategic Alignment	Has the applicant demonstrated how their initiative aligns to council's strategic priorities and goals? Has the applicant demonstrated that the initiative aligns to Council's community outcomes and strategic priorities?	1
Capacity and Experience	Does the applicant have the capability, capacity, and experience to deliver the project, activity, or service to an appropriate standard? Is this evidenced by a relevant track record of successful delivery or a clear plan of how they intend to deliver? Has the applicant identified areas where it would value additional support?	0.5
Evidence Based Budget	Does the applicant present a realistic, evidence-based budget for the project, activity, or service? Does this budget include all elements of the project? Has the applicant identified how the grant will be spent? Has the applicant evidences other funding streams in their budget if applicable?	0.5
Success Evaluation	Has the applicant identified how the success of the project, activity or service will be evaluated? For example, will any information be collected on the number of people benefiting from the initiative?	0.5
Project Benefit	Has the applicant identified who the project, activity or service will benefit and where in the Taupō district these people reside?	1
Community Support	Has the applicant provided evidence of community support, collaboration or involvement in the project, activity, or service? For example, volunteer hours, or donated goods/services? Has the applicant provided evidence of support from a recognised regional or national body (where relevant)?	0.5
